ITEMS PUT FORWARD BY THE BROMSGROVE TAXI OPERATORS, OWNERS AND DRIVERS ASSOCIATION RELATING TO NON-CONFIDENTIAL AND NON-EXEMPT ITEMS

The following items were submitted.

Arising therefrom:

(1) HACKNEY CARRIAGE METER TESTS

Following the ensuing discussion in respect of the how frequent Hackney Carriage meters should be tested, it was

RESOLVED: that the request put forward by the Association to reduce the frequency of meter testing to once a year for all vehicles, irrespective of age, be approved.

(2) SURCHARGES FOR MID-TERM TESTS

The Association expressed their dissatisfaction at the lack of communication between the Council and the Taxi trade with regard to the introduction of the surcharges to cover the cost incurred by the Council for all mid-term tests. It was felt that the surcharges should have been advertised at the same time as the notification of the increase to the licence fees.

The Association questioned whether or not the Council had broken a contract with those applicants who had applied for either a Hackney Carriage or Private Hire Vehicle Licence prior to the 1st April, which was when the surcharges for the mid-term tests were introduced, as the applicant was unaware at the time of making the application that they could incur additional costs depending upon the age of their vehicle.

The Head of Administrative Services agreed to seek advice on the legal position of those Drivers who had applied for a Vehicle Licence prior to 1st April.

(3) INCREASE THE LICENCE FEES FOR ALL VEHICLES

The Association put forward a request that the current surcharges which were applicable to those vehicles which were subject to additional mid term tests be withdrawn, and that the licence fees for

all Hackney Carriage and Private Hire Vehicles be increased by an additional £20.00.

The Head of Administrative Services explained that the cost to the Council for mid term tests was in the region of £4000. The suggested increase of £20.00 would not generate enough income to cover the cost of the additional tests. The increase in licence fees would need to be in the region of £38 per vehicle. The introduction of a flat-rate increase applied to all vehicles would have the effect that the owners of newer vehicles would be contributing towards the additional costs to the Council of having to test the older vehicles more frequently.

(4) <u>CONSULTATION ON LICENCE FEES AND HACKNEY CARRIAGE</u> <u>FARES</u>

The Association requested that they be included in any further consultations in respect of licence fees and Hackney Carriage Fares. It was further suggested that the Council undertakes a review of its policy with regard to fixed fares.

The Head of Administrative Services agreed to submit a Report to the Council's Executive Cabinet on the Council's policy with regard to introducing maximum fares relating to Hackney Carriages, thus allowing for discounted fares being offered to those persons on low incomes.

(5) <u>INTRODUCE AN UPPER AGE LIMIT ON VEHICLES AND/OR</u> INTRODUCTION OF TYPE/COLOUR REQUIREMENTS

The Association sought confirmation that the Council was not considering the introduction of an upper age limit on licensed vehicles, or a requirement that vehicles should be of a particular type and/or colour.

It was reported that the Council had no intention at present to introduce such a scheme.

(6) TESTING CENTRES

The Association expressed their concern at the poor levels of customer care and lack of attention or inconsistency in the testing methods of the vehicles. Furthermore, they would like to see more flexibility in the testing time slots currently offered by the Depot, particularly for those Drivers who carry out school contract work.

Members were further informed that once a vehicle passed its test it was issued with a 'certificate of compliance'. Although this constituted a valid MOT certificate it was not usually acceptable should a driver wish to sell his vehicle to a private buyer.

It was agreed that the Head of Administrative Services investigate the feasibility of contracting the work out to an alternative MOT testing garage(s), thus allowing more flexibility for the Drivers. The report be submitted to a future meeting of the Licensing Committee.

(7) INCREASE IN EXPENDITURE

This item had already been dealt with prior to the Meeting.

(8) 'TWO DOOR RULE'

The Association sought an explanation as to why the Council insists that each licensed vehicle has two uninterrupted access/exit doors.

Furthermore, it was reported that there is no consistency with regard to this condition across the County.

The Chairman explained that the 'two door rule' is for safety reasons, to ensure that passengers can escape for the rear seats of a larger vehicle by two different routes in the event of an accident.

It was agreed that a report be submitted to a future meeting of the Licensing Committee in respect of the Council's Policy relating to the 'two door rule' and the seating configuration of vehicles licensed to carry more than four passengers.

(9) ANY OTHER BUSINESS

(a) First Aid Kits

The Association questioned why there was a need for all vehicles to carry a first aid kit within their vehicle, particularly in view of the fact that none of the drivers were medically trained to offer first aid assistance.

It was agreed that the contents of the first aid kit would be looked at and would be subject to a report to a future meeting of the Licensing Committee.

(b) Thanks

Mr Nind, on behalf of the Association thanked the Licensing Committee for their continued support to the taxi trade and stated that it had been a successful meeting.

1. <u>APPLICATION TO GRANT AN OCCASIONAL PUBLIC ENTERTAINMENTS LICENCE - WASELEY HILLS COUNTRY PARK, RUBERY</u>

An application has been received for the granting of an Occasional Public Entertainments Licence on behalf of Waseley Hills Country Park, Rubery. The proposed event is for the 'On Your Doorstep' Multi-Cultural Picnic', which will be held on Saturday 10th September 2005, starting at 10.00am and finishing at 3.30 p.m. During the course of the event, there will be artists undertaking various art activities including the performance of steel drums as well as background Latin music for dance workshops.

The Police Authority, Fire Authority and the Director of Environmental Services have no objections to the granting of the Licence.

The application has been advertised, and no responses have been received.

If Members are minded to grant the application, then it would be subject to the Council's standard conditions.

2. <u>APPLICATION TO PROHIBIT THE CONSUMPTION OF ALCOHOL IN DESIGNATED PUBLIC PLACES - RUBERY</u>

The Council has received a request from Cllrs. P. McDonald and C. Wilson, Ward Members for the Waseley Ward, seeking that the Council considers making a further Order to prohibit the consumption of alcohol in three designated public places in Rubery. The areas affected by the proposed Order are School Road, Gunner Lane and Woodlands Road, Rubery.

In accordance with the Local Authorities (Alcohol Consumption in Designated Public Places) Regulations 2001, the Council is required to consult with the Police, Licensees of any licensed premises in the vicinity of the designated places, together with owners and occupiers of the land.

The Police have been consulted on the proposal; they have stated that there is alternative legislation in place to deal with the purchase and consumption of alcohol by young persons in public places. However, if there was an element of adult involvement in the problems, which are occurring in the areas identified, then they will reconsider the proposals.

No objections have been received from local Licensees who have been consulted.

3. FIRST AID KITS IN LICENSED HACKNEY CARRIAGES AND PRIVATE HIRE VEHICLES

Arising from the meeting with the Bromsgrove Taxi Owners' and Operators' Association, one of the items which the Committee asked for a report on was the requirement to carry a first aid kit in each licensed vehicle.

The points made by the Association were as follows;

- The first aid kits are little used (if at all), because few if any drivers are trained in first aid and all would be reluctant to deliver first aid for fear of being sued if anything went wrong.
- The first aid kits are quite expensive to assemble, costing around £35 £40.
- The contents prescribed by the Council are out of date and some are not particularly useful, e.g. eye patches. Some articles are difficult to acquire in the sizes which are prescribed.

The present requirement is that each vehicle should carry a first aid kit, which includes the following articles:

- (a) ten antiseptic wipes, foil packed;
- (b) one conforming disposable bandage (at least 7.5cm wide);
- (c) two triangular bandages;
- (d) packet of 24 assorted plasters;
- (e) three large sterile unmedicated ambulance dressings (at least 15x20 cm);
- (f) two sterile eye pads with attachments;
- (g) one pair of rustless blunt-ended scissors.

The list was drawn up on the basis of Health and Safety Executive guidance issued in the 1980s.

There are two questions to answer:

- (a) Is it appropriate for the Council to continue to require first aid kits to be carried?
- (b) If so, is the present list of contents appropriate?

The answer to the first question is a matter of judgement. It is true that these days many people are more cautious about actions such as giving first aid, because of the possibility that they will be sued if something goes wrong. On the other hand, that argument may not apply to everyone, and certainly does not apply in a situation where someone may wish to administer first aid to themselves, e.g. by putting a plaster or a dressing on a cut, or by rubbing on a bit of antiseptic cream. The lack of first aid training is not an argument in such simple situations. It should also be noted that the person most likely to require the use of a first aid kit will be the driver of the vehicle, who is the person who spends the most time in the vehicle. Although the point that there may be reluctance to use a first aid kit is noted, there will also be situations where the absence of one could cause difficulties and it may be considered that, on the whole, there are advantages in retaining the requirement that each vehicle should have a first aid kit.

The answer to the second question is probably "no". Bearing in mind the arguments for simplicity and ease of use by everyone, the requirements for bandages of a particular size and shape, and for eye patches, seem to be unnecessary. There are arguments for being less prescriptive, particularly bearing in mind what the vehicle owners have said about the cost and difficulty in acquiring some items. A recent visit to Halfords revealed that they sell a sizeable motorist's first aid kit, containing plasters, bandages, dressings, sling, antiseptic cream and scissors for £14.99, less than half the cost reported by the vehicle owners at the recent meeting. If the Committee believes that it is justified to continue to require a first aid kit, then it may also consider it appropriate to move to a simplified requirement, based on the above.

The other point made at the meeting relating to first aid kits was the alleged refusal of the staff at the Depot to allow a first aid kit to be transferred from a vehicle which is no longer licensed to its replacement. This is emphatically denied - the Depot's testing centre even keeps a marker pen for use by vehicle owners who need to write a new registration number on to their

first aid kit or fire extinguisher. However, it is necessary for the Council to make checks to ensure that first aid kits (and fire extinguishers) are not circulated between several licensed vehicles, the one with the first aid kit, being the one which is due in for a test(!). This is why the requirement for the first aid kit (or fire extinguisher) to bear the vehicle's registration number needs to be retained.

The Committee's views on questions (a) and (b) above are sought.
