### **REPORT OF THE HEAD OF ADMINISTRATIVE SERVICES RELATING TO NON-CONFIDENTIAL AND NON-EXEMPT ITEMS**

1. **APPLICATION TO RENEW AN ANNUAL PUBLIC ENTERTAINMENTS LICENCE - THE QUEENS HEAD, SUGARBROOK LANE, STOKE POUND**

An application has been received for the renewal of an Annual Public Entertainments Licence on behalf of Mr. J. Fidoe in respect of The Queens Head, Sugarbrook Lane, Stoke Pound, Bromsgrove.

The Police Authority and the Director of Environmental Services have no objections to the renewal of the Licence.

The application has been advertised, and no responses have been received.

If Members are minded to renew the application, then it would be subject to the Council's standard conditions and any additional conditions already stipulated in the Licence.

2. **REVIEW OF FEES FOR STREET TRADING CONSENTS**

At its meeting on 13th June 2005, the Committee asked that a report be submitted to a future meeting to enable it to review the fees paid for Street Trading Consents in Bromsgrove High Street.

The Council has adopted powers to regulate most kinds of street trading in Bromsgrove High Street and parts of surrounding streets, such as Church Street and Chapel Street. The powers allow the Council, when it does grant a permit to someone, to make a charge. This charge was fixed at £10 when the powers were adopted in the 1980s and has remained at this level since then.

However, the Council's policy is not to grant street trading permits except in the most exceptional circumstances. The only permits which are now granted are (a) for the regular monthly Farmers' Markets (paid for by the Council itself), (b) for the annual Elizabethan Street Market held in June each year (paid by the Hospital Carnival Committee) and (c) for the hot dog stall which is brought in on the day of the Christmas Lights Switch-on (paid for by the operator). Until recently a permit was also granted for sales of doughnuts etc. during the period around Christmas, but the Committee has now decided that this permit will not be granted. The amount of income received from the Council from Street Trading Consents is therefore minimal.

The Council does, however, make additional charges for the stalls in the Farmers' Markets, which are £25/day for a "standard" stall and £35/day for a "double" stall. However, these are intended to cover the cost of providing and setting up the stalls and are not directly connected to the street trading consent.

Enquiries have been made of other Councils about the amounts which they charge:

Redditch - street trading not permitted

Wychavon - annual licences £375-£535, occasional consent £37.50-£53.50

Worcester - annual licences £2885-£5360, day fee £53 plus £12 for each day after the first, mobile units (e.g. ice cream vans) £78.

Birmingham - wide range of charges, from £1666 in the suburbs up to £6600 in the City Centre

Wyre Forest - annual licences £998-£1330, mobile units £520

Unless the Council's policy changes to permit regular trading, there is no point in setting a charge for an annual licence.

The comparable charges made by Wychavon and Worcester for temporary permits suggest that it might be appropriate to increase the charge made by this Council for the temporary consents from £10 to around £50. However, it should be borne in mind that the only two payments which are made to the Council are from a charitable organisation (in the case of the Carnival Committee) and from a fairground operator who has previously indicated that the financial benefits to him of attending at Bromsgrove are at best dubious and who might be discouraged from attending in future years if the charge was increased in the way suggested.

In view of this, the Committee may wish to agree that the present charge of £10 be retained and that the situation should be reviewed only if the Council's policy towards the granting of consents changes.
