REPORT OF THE HEAD OF ADMINISTRATIVE SERVICES **RELATING TO NON-CONFIDENTIAL AND NON-EXEMPT ITEMS**

1. **APPLICATION TO GRANT AN ANNUAL PUBLIC ENTERTAINMENTS LICENCE –**
ARTRIX, SCHOOL DRIVE, BROMSGROVE

An application has been received for the granting of an Annual Public Entertainments Licence on behalf of Mr. A. Woods in respect of Artrix, School Drive, Bromsgrove.

The Director of Environmental Services and the Police Authority have no objections to the granting of the Licence. Comments are awaited from the Fire Authority.

The application has been advertised, and no responses have been received.

The applicant is also seeking approval for the licence fee to be waived, on the following grounds:

Artrix is operated by the Bromsgrove Arts Centre Trust, which is a registered charity and was established to advance education in and increase appreciation and understanding of all forms of arts amongst members of the public including (without limitation) drama, dance, music and performance and visual arts generally. The applicant has stated that much of the work of Artrix will be linked to formal education through local schools and colleges, it will promote directly and in partnership with other programmes of theatre and dance performance, and general music concerts and exhibitions. Artrix will also screen specialist programmes of arthouse, archive and world cinema. To summarise, the applicant has stated that Artrix is an educational charity and provider of cultural rather than commercial recreation.

If members are minded to grant the application, then it would be subject to the Council's standard conditions.
