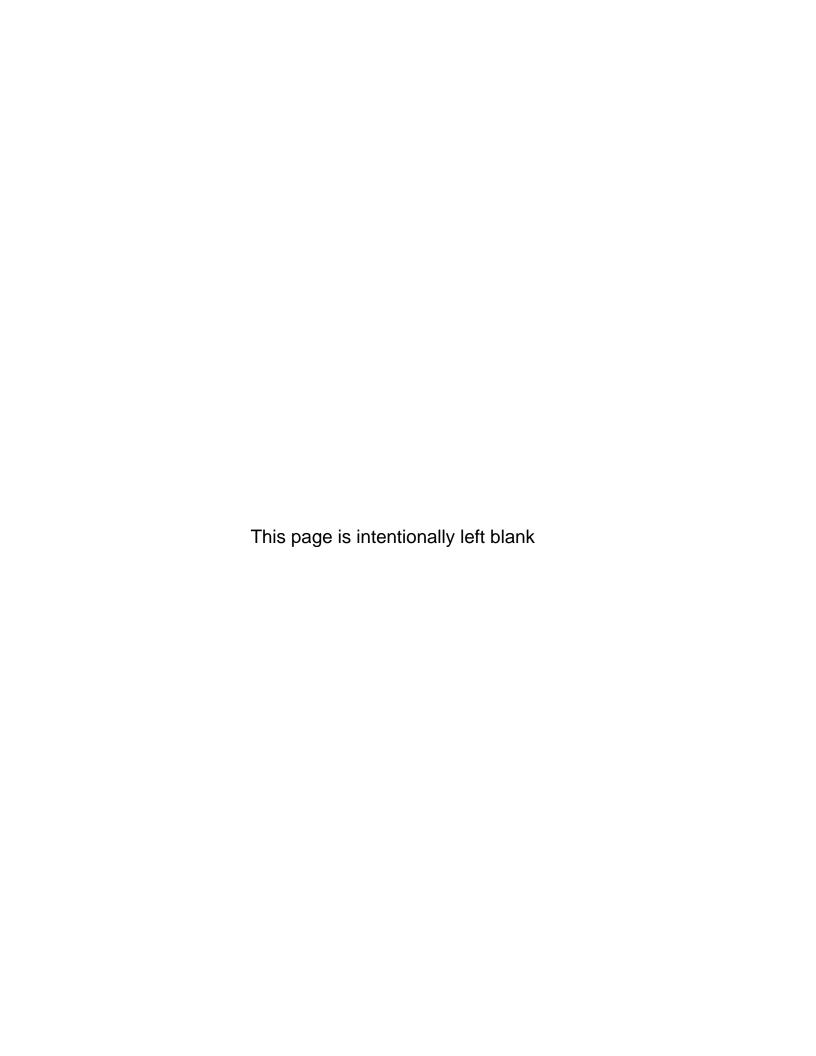

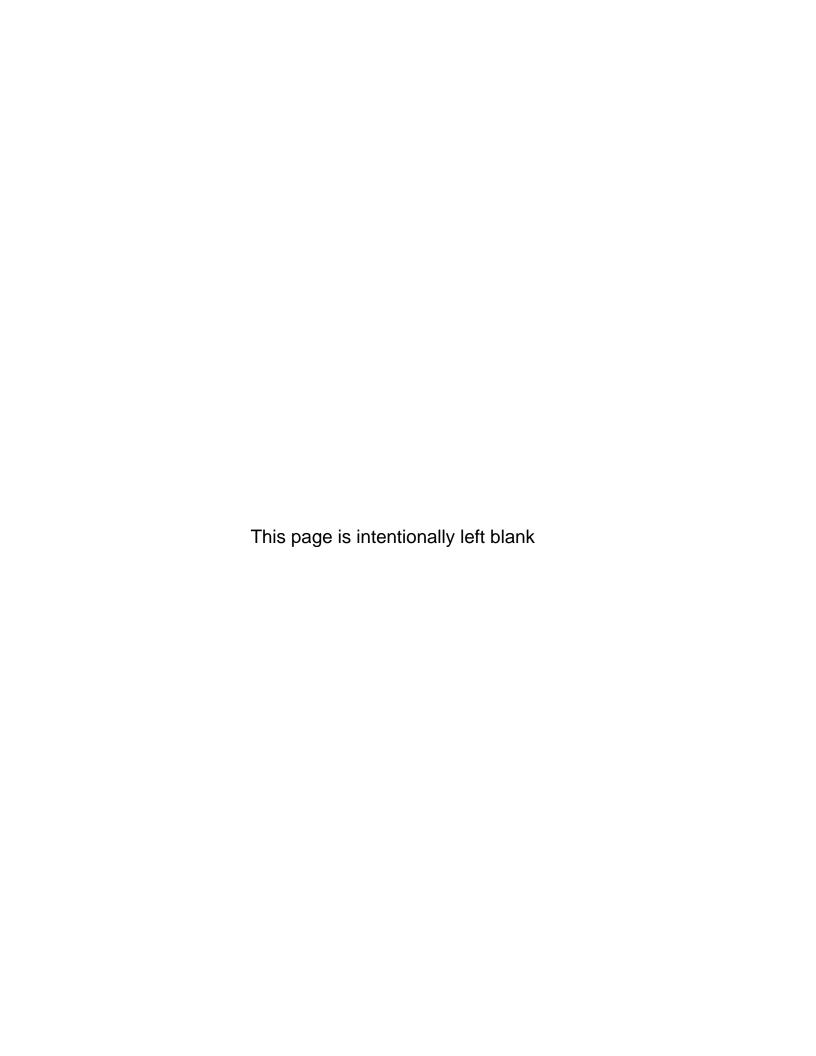

NOTICE OF MOTION – NEW HOMES BONUS AND FUNDING OF COMMUNITY PROJECTS

The following Notice of Motion has been submitted in accordance with Procedure Rule 11 by Councillor S. R. Colella:

"That this Council, recognising the impact upon the District's communities that are being affected by housing development, asks that Cabinet consider, as part of their discussions on any proposed allocation of New Homes Bonus from 2015/16, the inclusion of £500k of the additional revenue surplus that was generated in 2013/14. This surplus, together with any proposals on the New Homes Bonus funding should be distributed to Community projects under the guidance of the New Homes Bonus".

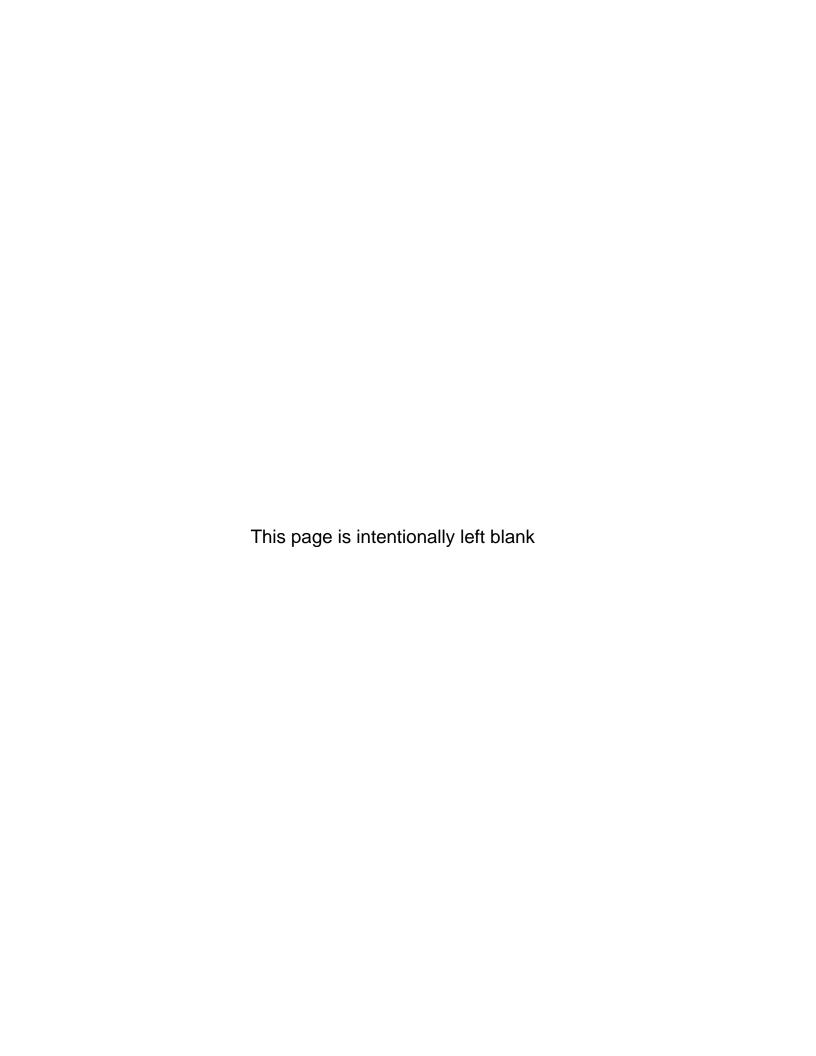

The following Notice of Motion has been submitted in accordance with Procedure Rule 11 by Councillor R. J. Laight:

I am aware that this Council has "led the way" in cost savings over recent years and unlike many Councils around the U. K. we do continue to have funds available to improve both services and support for our residents and local businesses.

I would like to put forward the Motion that Cabinet investigates further, as part of the on going budget process, the use of some of the saved funds from projects successfully delivered, such as the Shared Management Team, to be used to support the town centre evening economy by running a trial on free car parking during the evening in our pay and display car parks for a 12 month period.

NOTICE OF MOTION - SMALL BUSINESS SATURDAY

The following Notice of Motion has been submitted in accordance with Procedure Rule 11 by Councillor C. J. Bloore:

"Council recalls its discussion of Small Business Saturday (SBS) last year. Council notes the growing profile and success of SBS nationally.

Council further notes initiatives such as Nottinghamshire County Council who offered free parking to shoppers last year on SBS and Liverpool City Council who offered two hours free parking permits. City of York Council created a pop up shopping centre.

Council is concerned that Bromsgrove town and village centres are able to take full advantage of SBS to promote local businesses and shopping local.

Council resolves:

- (i) to support SBS 2014 on 6th December and to identify ways to promote our small businesses through this annual event.
- (ii) to put in place a comprehensive communications plan to promote SBS across the District across all the Council's communication channels.
- (iii) to use SBS as an opportunity to promote local businesses and to encourage local businesses to open in our town and village centres.
- (iv) to ask the Leader and Cabinet to urgently consider further practical initiatives to bring more customers into the town and village centres, including but not limited to, a parking discount for SBS."
