## **AGENDA - URGENT MEETING**

In accordance with the Council's Constitution and in consultation with the Chairman of the Standards Committee, this meeting is being convened at less than 5 clear days' notice for reasons of urgency.

The reasons for urgency are as follows:

- (i) It was not possible to deal with the pre-hearing issues at the diarised meeting of the Committee on 26th January 2011 following a request from the Subject Members' representative for additional time in which to complete the necessary pre-hearing questionnaires; and
- (ii) A meeting of the Committee is required at this stage in order to allow sufficient preparation and notification time to carry out the remainder of the requirements under the pre-hearing process.

"That under Section 100 I of the Local Government Act 1972, as amended, it/they involve the likely disclosure of <u>exempt</u> information as defined in Part I of Schedule 12A to the Act, as amended, the relevant paragraphs of that part being (...to be specified by the Chairman at the meeting), and that it is in the public interest to do so.", and/or

"That under Section 100 A of the Local Government Act 1972, as amended, it/they involve the likely disclosure of <u>confidential</u> information which would be in breach of an obligation of confidence."]
