## **INFORMATION FOR THE PUBLIC**

### **Access to Information**

The Local Government (Access to Information) Act 1985 widened the rights of press and public to attend Local Authority meetings and to see certain documents. Recently the Freedom of Information Act 2000 has further broadened these rights, and limited exemptions under the 1985 Act.

- You can inspect agenda and public reports at least five days before the date of the meeting.
- You can inspect minutes of the Council, Cabinet and its Committees/Boards for up to six years following a meeting.
- You can have access, upon request, to the background papers on which reports are based for a period of up to six years from the date of the meeting. These are listed at the end of each report.
- An electronic register stating the names and addresses and electoral areas of all Councillors with details of the membership of all Committees etc. is available on our website.
- A reasonable number of copies of agendas and reports relating to items to be considered in public will be made available to the public attending meetings of the Council, Cabinet and its Committees/Boards.
- You have access to a list specifying those powers which the Council has delegated to its Officers indicating also the titles of the Officers concerned, as detailed in the Council's Constitution, Scheme of Delegation.

## **LICENSING SUB-COMMITTEE (Premises)**

### **HEARING PROCEDURE**

1. The Chairman will open the hearing and ask Members of the Sub-Committee and officers present to introduce themselves.
2. The Chairman will ask all parties to the proceedings to introduce themselves.
3. The Charman will ask all parties if they are satisfied with the hearing procedure to be followed. Any variation to the hearing procedures will be at the discretion of the Chairman.
4. The Technical Officer (Licensing), Worcestershire Regulatory Services will present the report.
5. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Technical Officer.
6. The Chairman will invite the Applicant and/or their representative to present their case and call any witnesses. A total of 15 minutes will be allowed.
7. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Applicant and/or their representative.
8. The Chairman will invite the Responsible Authorities to present their representations. A total of 15 minutes will be allowed.
9. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Responsible Authorities.
10. All Other Parties to the proceedings will be invited to present their representations or elect a spokesperson to speak on their behalf. A total of 15 minutes will be allowed.
11. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Other Parties.
12. The Responsible Authorities will be invited to sum up. A total of 5 minutes will be allowed.
13. The Other Parties will be invited to sum up. A total of 5 minutes will be allowed.

# Appendix

14. The Applicant and/or their representative will be invited to sum up. A total of 5 minutes will be allowed.
15. The Chairman will ask the Legal Advisor if there is any legal advice to be given.
16. The Chairman will close the Hearing so that the Sub-Committee can reach its decision in private.
17. The Sub-Committee's decision will be confirmed in writing to the Applicant and those parties who made representations within 5 working days.
18. If any party to the proceedings wishes to appeal against the Sub-Committee's decision an appeal must be commenced by the appellant giving a notice of appeal to the designated officer for the magistrates' court within a period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision which is being appealed.

## **NB**

In considering any representations or notice made by a party the Sub-Committee may take into account documentary or other information produced by a party in support of their application, representations or notice either before the hearing or with the consent of all other parties at the hearing.

**1. PURPOSE OF REPORT**

- 1.1. To consider and determine an application for variation of the premises licence in respect of the premises below:

**Dodford Inn**  
**Whinfield Road**  
**Dodford**  
**Bromsgrove**  
**Worcestershire**  
**B61 9BG**

- 1.2. A copy of the application is attached at **Appendix 1**.
- 1.3. A copy of the existing licence is attached at **Appendix 2**.

## 2. BACKGROUND

- 2.1. On 27 March 2025 an application was received from Gina & David John Myatt for variation of the premises licence in respect of

**Dodford Inn  
Whinfield Road  
Dodford  
Bromsgrove  
Worcestershire  
B61 9BG**

- 2.2. The application contained all the requisite documentation including the fee.
- 2.3. It can be confirmed that the application has been advertised in accordance with the requirements of the Licensing Act 2003 and associated regulations and that the application has also been served on all responsible authorities.

- 2.4. The current licence authorises the following activities on the premises

Sale of alcohol from 10:00 hours until 23:00 hours Mondays to Thursdays, 10:00 hours until 00:00 hours Fridays to Saturdays, 11:00 hours until 23:00 hours on Sundays.

Live music from 10:00 hours until 00:00 hours Fridays to Saturdays.

Recorded Music from 10:00 hours until 00:00 hours Fridays to Saturdays.

- 2.5. The licence permits the following non standard timings:

All licensable activities shall finish at 12 midnight on the following notable days/dates:  
Every Monday and Sunday for all Bank Holidays, namely, Easter, Early May Bank Holiday, Spring Bank Holiday and August Bank Holiday;  
Every Thursday prior to Easter Bank Holiday;  
Christmas Eve; and  
Boxing Day.  
Christmas Day - 12:00 - 15:30 & 19:00 - 23:00  
New Year's Eve - All licensable activities listed are permitted till the start of trading hours on New Year's Day.

- 2.6. The applicant is applying for the following variations to their existing licence:

Removal of all non standard timings.

Amendment to permitted alcohol sales hours - Permit the sale of alcohol from 10:00 on Sundays, Mondays, Tuesdays, Wednesdays and Thursdays (currently 11:00), aligning with Friday and Saturdays.

Permit the sale of alcohol until 00:00 on Sundays, Mondays, Tuesdays, Wednesdays and Thursdays (currently 23:00), aligning with Fridays and Saturdays.

Removal of Annex 3 - This condition currently restricts the use of the outside patio area by customers after 23:20. We request its removal to allow continued monitored use of the area.

Extension of the licensed area in accordance with the attached drawings.

- 2.7. Officers have noted that the applicants have requested the extension of Live and Recorded Music until 00:00 Sundays to Thursdays. The proposal to extend the hours for live and recorded music is no longer being pursued by the applicants, therefore this proposal will not be considered as part of this application.
- 2.8. The Live Music Act 2012 permits licensed premises to have Live and Recorded Music until 23:00, therefore the premises is permitted to have Live and Recorded Music until 23:00 Sundays to Thursdays.

### **3. REPRESENTATIONS**

#### **RESPONSIBLE AUTHORITIES**

- 3.1. The application has been forwarded to all responsible authorities prescribed under the Licensing Act 2003. No representations have been received from any of these responsible authorities.

#### **OTHER PERSONS**

- 3.2. 13 valid representations have been received from other persons relating to concerns for the potential for public nuisance. Representations raise concerns regarding the protection of children from harm and public safety. Some of the representations allude to the potential for disorder. A copy of these representations are attached at **Appendix 3**.

### **4. LOCAL POLICY CONSIDERATIONS**

- 4.1. The Sub-Committee should have regard to the Council's Statement of Licensing Policy under the Licensing Act 2003.

### **5. LEGAL IMPLICATIONS**

- 5.1. The Sub-Committee is obliged to determine this application with a view to the promotion of the licensing objectives which are:
  - the prevention of crime and disorder;
  - public safety;
  - the prevention of public nuisance;

- the protection of children from harm.
- 5.2. In making its decision, the Sub-Committee is also obliged to have regard to the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003 and the Council's own Statement of Licensing Policy.
  - 5.3. The Sub-Committee must also have regard to the representations made and the evidence it hears.
  - 5.4. The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
    - (a) Grant the application as requested
    - (b) Modify the conditions of the licence, by altering or omitting or adding to them.
    - (c) Reject the application in whole or in part.
  - 5.5. The Sub-Committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.
  - 5.6. All parties to the hearing will be notified of the Sub-Committee's decision in writing within five working days of the conclusion of the hearing.
  - 5.7. Any party aggrieved by a decision taken by the Sub-Committee may appeal against the decision to a Magistrates' Court within 21 days of being notified of the decision in writing.
  - 5.8. The hearing should be conducted in accordance with the agreed procedure.

The conditions contained within Annex 2 of the existing premises licence will be extended to cover the additional opening times requested in this application. Staff will be updated upon the conditions and the implications of failure to work in line with these conditions.

**b) The prevention of crime and disorder**

Staff are instructed to refuse to serve alcohol to anyone appearing to be adversely affected by alcohol or other substances. If this type of incident should occur then any persons suspected will be asked to remove themselves from the premises and escorted by staff and/or management to ensure everyone's safety and maintain peace.  
A number of additional security cameras have been installed at strategic points to aid facial recognition on entry and activities within the grounds of the venue.  
Patrols by management take place at regular intervals throughout functions in order to spot and monitor any potential infringements.

**c) Public safety**

The additional security cameras will assist in maintaining public safety.  
A defibrillator has been installed and registered on the outside of the building. This will add to public safety in the event of sudden incidents of potential life threatening conditions.

**d) The prevention of public nuisance**

Additional security cameras assist with the spotting of potential incidents of public nuisance which will be backed by regular patrols conducted by management around the full perimeter of the grounds and buildings.  
Conditions applied to contracts for events will contain instruction and information on both management and customer responsibilities to public nuisance.  
Air conditioning has been installed in all public areas of the building, thus allowing windows and doors to be kept shut during amplified music performances.  
No outdoor music to be allowed after 23:00 hrs on any night.

**e) The protection of children from harm**

Existing conditions for the protection of children will remain in place and be fortified by the additional security camera system and the regular patrols by management throughout the venue.

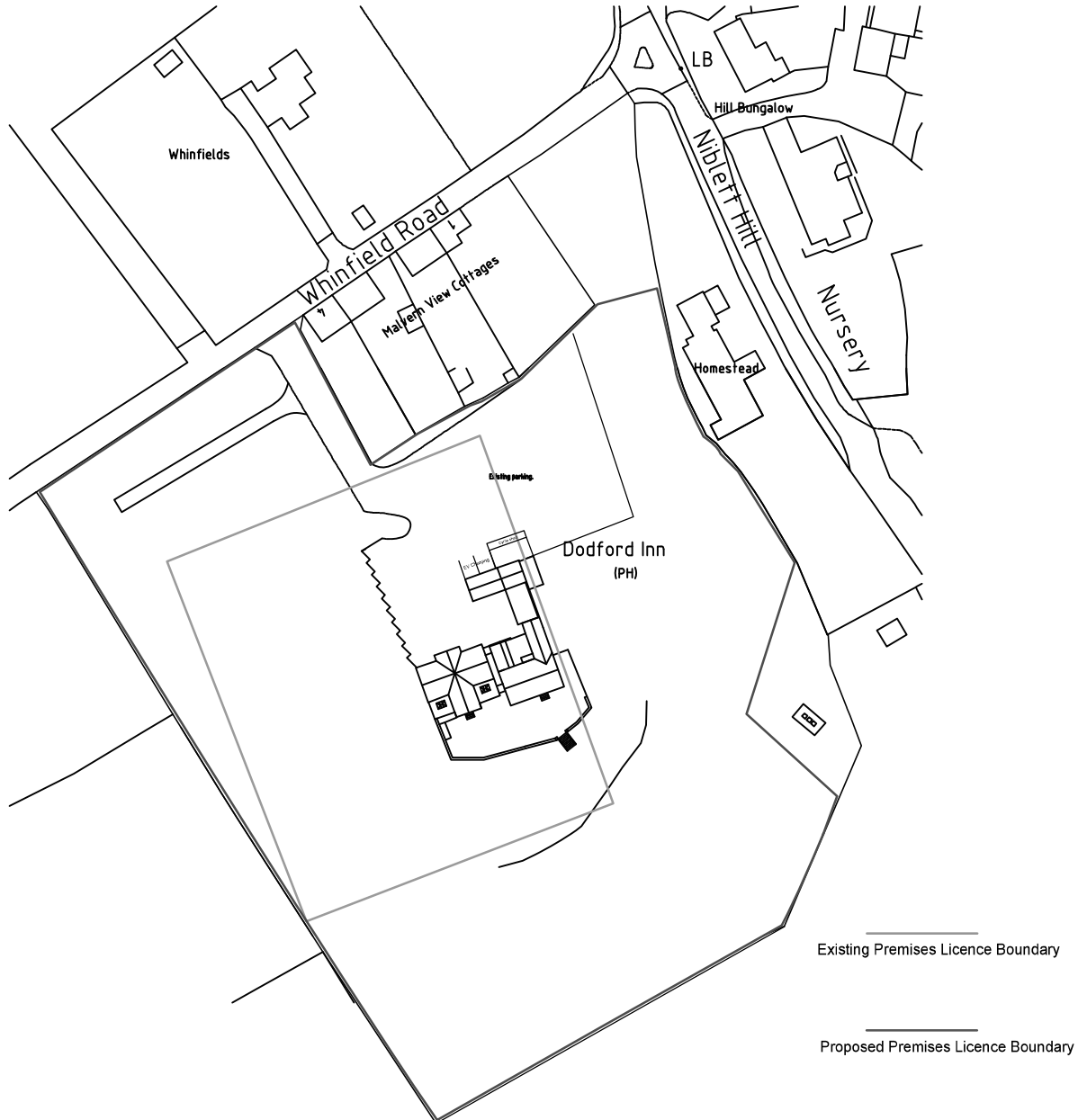

## LOCATION PLAN Scale 1:1250



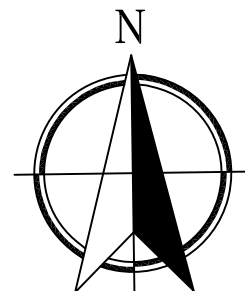

## ANNEX 1 – MANDATORY CONDITIONS

### The making and authorisation of alcohol sales

No supply of alcohol may be made under the premises licence—

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### Irresponsible alcohol promotions

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
  - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

### Provision of free potable water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

### Age verification policy for the sale or supply of alcohol

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

### Availability of small measures of alcohol

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

## **Permitted price of alcohol**

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
2. For the purposes of the condition set out in paragraph 1—
  - a) “duty” is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - b) “permitted price” is the price found by applying the formula—
$$P=D+(D\times V)$$
where—
    - P is the permitted price,
    - D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
    - V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence—
    - (i) the holder of the premises licence,
    - (ii) the designated premises supervisor (if any) in respect of such a licence, or
    - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - e) “valued added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4.
  - (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## ANNEX 2 – CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

### a) General – all four licensing objectives (b,c,d,e):

The Licence Holder and DPS will control any potential negative impact to local residents by operating the premises in a considered and well managed way.

All reasonable steps will be taken to minimise the impact of licensable activities and any potential anti-social behaviour on the immediate surroundings of the premises.

Consideration will be given to staff training so that they are aware of the premises licence and the licence requirements to meet the four Licensing objectives.

### b) The prevention of crime and disorder:

Serving staff will be given guidance on how to refuse alcohol sales to any persons who appear drunk.

Serving staff will be given guidance on how to identify and deal with proxy sales alcohol to persons who appear to be under the age of 18.

CCTV to be installed as follows:

CCTV cameras are located within the premises to cover public areas including entrances and exits.

The system records clear images permitting the identification of individuals.

The CCTV system is able to capture a minimum of 8 frames per second and all recordings footage must be securely retained for a minimum of 31 days.

The CCTV system operate at all times while the premises are open for licensable activities. All equipment will have a constant and accurate time and date generation.

The CCTV system is fitted with security functions to prevent recordings being tampered with, i.e password protected.

Members of trained staff will be available at the premises during operating hours and be able to provide viewable copies on request to police

SIA Staff will be employed when it is deemed by a risk assessment that these will required or when asked to do so by the police, local authority or any other relevant authority.

### c) Public safety:

The maximum number of people permitted on the premises is calculated and detailed within the fire risk assessment and that number that number will not be exceeded within the hours of any licensed activity. This figure is currently agreed at 150 persons seated and 240 standing. This figure includes staff and management.

All parts of the premises and all fittings and apparatus therein , lighting, heating, air-conditioning and other installations will be maintained in good order and in safe condition.

### d) The prevention of public nuisance:

Public notices will be placed at the entrance/exit and in all outside areas to remind customers of the need to respect neighbours and leave the premises quietly.

### e) The protection of children from harm:

No unaccompanied children under the age of 16 will be allowed to remain on the premises during the hours of Licensing activities.

Accompanied children present at licensable activities will have been assessed under risk assessment of the management and staff prior to events and staff will work with responsible guardians will work together to ensure the health and safety of those considered vulnerable.

GHALLENGE 25

The staff and management will operate the challenge 25 scheme within the premises.

Appropriate signs informing of the operation of the Challenge 25 will be displayed within the premises.

All staff will be trained in the understanding of the Challenge 25 scheme.

A Refusals and Challenge log will operate alongside the Challenge 25 and ensure all challenges made by staff are fully recorded in the log including: Date, Time, Member of staff involved and ID produced Y/N.

A refusals record will be kept at the premises which details all refusals to sell alcohol. This record will include the Date and Time of the incident and a description of the customer, along with the name of the member of staff who refused service, along with a clear reason for the refusal. All entries will be made within 24 hours of the refusal. The record will be made available for inspection and copying within a reasonable time of a request by an officer of any responsible authority.

## **Other operating conditions**

Conditions agreed with West Mercia Police February 2024;

Authorised for the Sale of Alcohol will be defined in a written document. This will detail who has authorised the sale of alcohol and evidence that the staff member has been trained to spot under age drinkers. This document will be signed by both the staff member and the DPS. This document will be left on site and will be made available to the police, local authority or any other relevant authority seeking inspection of a copy.

An Incident Book The premise must record all incidents occurring on the premises. These include First Aid, Removal of Persons, Any injury sustained and persons refused the sale of alcohol. This can be reviewed by a relevant authority seeking this request. Full training will be given to all staff on how to use the incident book.

## **ANNEX 3 – CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY**

(1) That a clear and legible sign be displayed, advising taxi drivers not to sound their horns in the car park; (2) That a sign be displayed in the pub stating 'Respect local residents as you leave', as well as advertising contact details of local taxi firms; and (3) That the Licence Holder and/or the Designated Premises Supervisor ensures that patrons do not congregate in the beer garden after 11.20 p.m. on any day other than for the use of a smoking area as has been designated. The management and staff will supervise this use from the time designated up to closing time.

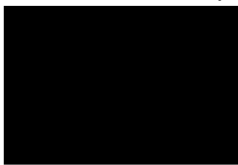

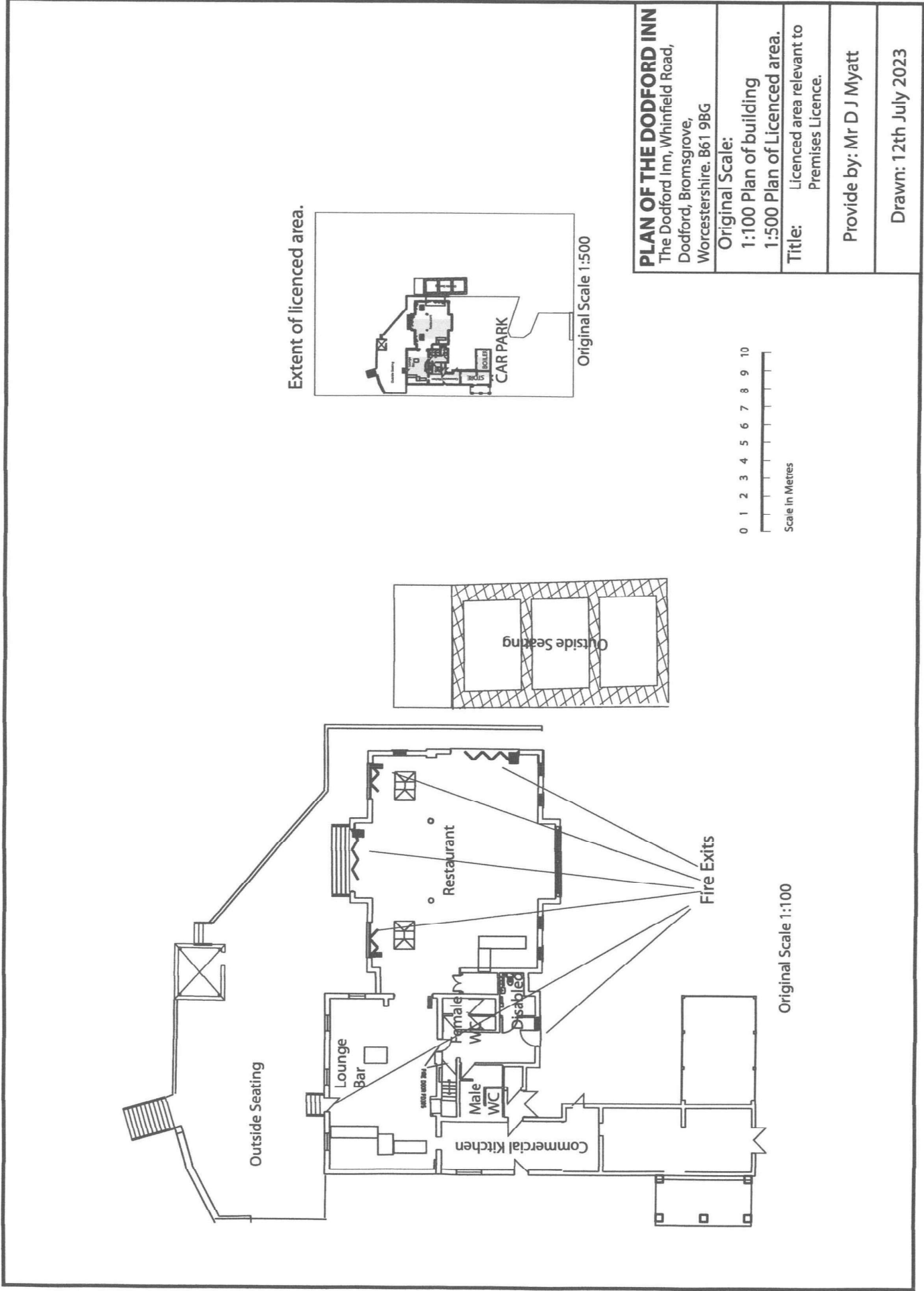

Dear Sirs,

I am writing to express my concerns about the proposed extended hours for the above Inn, during the week and at the weekend, as well as the ability to sell alcohol outside of the actual Inn itself.

Whilst I wish the business well, I live half a mile away, and yet found myself last summer, having to sleep with my windows closed whenever they either had music playing, or musicians playing outside, or hadn't actually closed their windows and doors, as sound travels down the valley.

As there are many families close to the pub, and others of us who work, and need to get a good night's sleep, so please do not extend the licensing hours.

I personally would also appreciate it, if you refused to let them sell alcohol outside of the premises, in order to protect the neighbouring properties, as well as those of us are further afield, but who hear the Dodford Inn as if they were their immediate neighbours. Hearing drunk people speaking loudly as they do, when you're outside, trying to enjoy one's garden, or even walk the dogs, isn't my favourite pastime.

Standard pub hours are acceptable, and are equal to the licensing of the Village Hall. I see no reason for any increase, especially as the owners have either made no attempt, or have been unsuccessful to monitor the sound omitted from the inn, which they said they would do when they applied for change of use last year - but then I understand there is no time limit that can be applied to these things!

Good morning,

We write to express our concerns and object to the application to amend the licence at the Dodford Inn.

As residents who live very close to the property, we feel there are many aspects that will have a negative impact on not only ourselves, but the wider community - Our response is written in line with the four licensing objectives.

The requested change to the premises licence boundary is of huge concern and, we feel, unnecessary. The current boundary allows ample space for the sale of alcohol while keeping it in the confines of the establishment. The change of area would bring the permitted sale of alcohol to within 10 meters of our property and would also extend down the field towards the nature reserve. We do not understand why this would be necessary, given that the current arrangement has been ample to provide for the number of people permitted to attend events.

Extending the boundary, has a huge potential to cause increased public nuisance with people being permitted to purchase alcohol so close to residential properties. We already experience noise from the people attending functions and that is within the current boundaries - this will be significantly worse if the boundary is moved.

The protection of children from harm: There are many children living within the area, as well as a first school and a charity for children which hosts residential visits, being located exceedingly close. The families and children that visit the centre are supported through the vision of the charity 'working with schools, social workers, health visitors and other referral agencies, to give children from deprived areas that much needed break and a 'breath of fresh air'. Families, children and groups can often be seen walking along the lanes of the village and Whinfield Road, having the boundary changed would mean that the sale of alcohol is permitted right next to the hedgerow along which children and many others walk frequently.

Public safety: If the boundary is increased for the sale of alcohol, it is likely to attract a larger number of people to visit, with the possibility of 'festival like' pop-up sales around the field. We are concerned,

The prevention of public nuisance: As already outlined, the change of the boundary would increase this aspect greatly. In addition to this, there have already been a number of occasions when the sound of the music from the pub can be clearly heard from our home. We understand that, in the initial application, there was a requirement for a noise meter to be fitted - this does not appear to have been completed and so we are already affected by the noise - increasing times and days of this would exacerbate this further. There are many families living in close proximity to the pub and to have to close your windows on a nice day to eliminate the noise is not acceptable.

We did phone the pub on an occasion as the sound was so loud, we now understand that this should have been sent to yourselves which we will ensure we do in the future.

When the initial planning application was granted, we understand that this was with a clause of the field not being used for any commercial use, if this was the case obviously, the boundary change would not be permitted.

It is difficult to understand how this change of licence is appropriate when residents of Dodford have so many planning constraints applied to their homes and properties due to living in a conservation area.

We understand how difficult it is to run a business, but strongly feel that the changes to the current application are not appropriate within the conservation area in which we live.

My objection is based on the grounds of **prevention of public nuisance**, specifically due to concerns regarding **noise disturbance**.

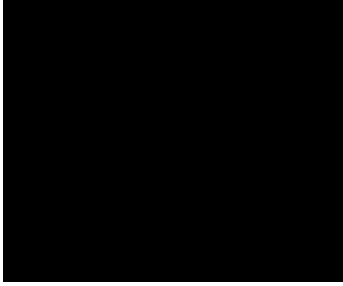

I am the immediate neighbour to the Dodford Inn and have lived in my house, [REDACTED] on Whinfield Road, for over 20 years.

The Dodford Inn is a traditional village pub and has been for 150 years without difficulties and has served the local community very well. There have never been problems with the operation of the pub with regards to the residents of Dodford. Since the pub became privately owned and gained additional planning approval as a wedding venue, access for the local community to visit the pub has been severely restricted with current opening on Friday, Saturday and Sunday lunch / afternoon providing there is not a private event booking – these take precedence. Increasingly there have been many more private events leading to even less opportunity to visit the pub.

The current situation is that there are now many occasions when private events mean serious disturbance to the community with loud music and shouting and screaming from people attending the events. This noise from partygoers appears uncontrolled by the pub management team. There is a fear within the community that any complaint or approach to the pub results in reprisal and members of the local community have been banned from the pub for such approaches. People are now wary about making representations. The pub management refuse to work in harmony with the local villagers. At the planning meeting to discuss the change of use to include being able to operate as a wedding venue the Chairman of the planning committee did not allow the Villagers the opportunity to speak at the meeting even though it was within his discretion to allow this.

The pub has a licence for indoor music, however by opening the folding doors and the use of the terrace and patio area the music is extremely loud outside. The noise can be heard across Dodford. In my house I can clearly hear the music and shouting with my windows closed. Even once the event finishes there is still noise whilst people wait for taxis and the noise on the field, which is being used as a carpark, is considerable and keeps me awake.

I'm also concerned about the likelihood of increase in traffic. With the proposed licence the pub could open every night serving alcohol until midnight. This would extend the drinking hours of those frequenting public houses in Bromsgrove / the locality and drinking could

continue at the Dodford. The access to the Dodford Inn is rural, along a narrow lane, past cottages that front onto the road. It is not safe for the increased level of traffic that is likely with an extension of the premises hours and opening potentially seven days a week, particularly for private events with the high numbers of people attending these events.

The removal of the restrictions on the terrace – currently it closes at 11:20am, would be extremely detrimental and cause public nuisance in its own right. The pub is situated in the heart of a residential

village. The sound from the grounds and field of the pub travels across the village. Currently the situation is disruptive and noisy, particularly when the music is played with the folding doors open – however currently this only can happen until 11:20pm. With the removal of the restriction this disruption could continue late into the night.

The current planning permissions for the Dodford Inn does not allow use of the field for any commercial use. Extending the use of the alcohol licence for serving alcohol across the whole of the site, as proposed by the application, would not fit with the current planning permission not to permit use of the field. My fields are adjacent to the pub field with a hedge between. I would find it very intrusive if the pub were to use the field for gin bars, marquees, selling alcohol for consumption on this part of the premises.

I would respectfully ask that the issues and difficulties highlighted in this letter are considered and that the application for the extension of both the hours and the removal of the terrace restrictions are refused based that they will cause a public nuisance to the villagers of Dodford.

I am writing as a concerned resident of Dodford to formally object to the proposed changes to the premises licence, as outlined in the recent communication to residents.

My objection is based on the following licensing objectives:

### **1. Prevention of Public Nuisance**

The proposed extension of alcohol sales until midnight throughout the week along with the removal of restrictions on the use of the terrace and patio areas, poses a serious risk of increased noise and disruption. Dodford is a quiet, rural area, and the current restrictions are in place to reflect and protect the peaceful character of our community. Allowing alcohol consumption and use of outdoor spaces late into the night would likely lead to disturbances, particularly for residents living nearby.

### **2. Public Safety**

Extending the licensed area to cover the entire site, along with longer alcohol sale hours, could lead to increased foot traffic, noise, and potentially unsafe situations involving intoxicated patrons moving around a larger and less controlled area. 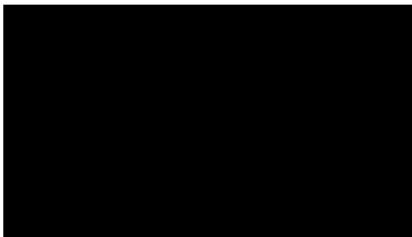

I live opposite the Dodford Inn and have lived in Whinfield Road for more than 20 years. The existing noise levels inside my well-insulated home from loud music & people shouting etc are already loud enough during events so that the TV at times needs to be turned up.

There are at least 5 properties closer to the pub than me, two of which have young families with children under 5 & two where elderly people live.

When cars pile in & out of the pub sometimes en masse it can gridlock the single track roads & make it difficult to get in & out of my property. At other times cars visiting the pub, & not from the vicinity, use Priory Road in particular as a race track. These are all safety concerns.

I am concerned too about anti-social behaviour. I have found glasses & bottles in & near my hedge so people are already not restricted to the premises themselves. This can only get worse if the area- which was only ever an agricultural field- & hours are extended.

Although I understand several local residents have previously contacted the pub directly about some of the above-mentioned issues, I have not. This is because I have previously experienced the present proprietors to be hostile & towards many other local residents in

addition. Also a few years ago when they took some land off a neighbour's garden, they said they were not for/ interested in the custom of local villagers, many of whom have an automatic ban.

I am a resident of Dodford and my house is opposite the Dodford Inn.

The pub lies in a semi rural location within the green belt surrounded by open fields. Extension of the hours to include all the days of the week and removal of non-standard timings will invariably increase noise, vehicular traffic and light pollution thereby adversely affecting the overall enjoyment of residents and the environment. The resident bats which are seen over the fields of the pub as well as other animals and wildlife will also be impacted.

Noise travels very easily over fields all around the village and disturbs the sleep of residents particularly those nearby. The level of noise from the use of the patio after 10.30pm at present has been very high with loud music and customers' voices. These disturb my sleep at weekends. The owners and managers have not been able to control the noise late at night so far and loud music can often be heard until very late at night with no regards for the neighbours. 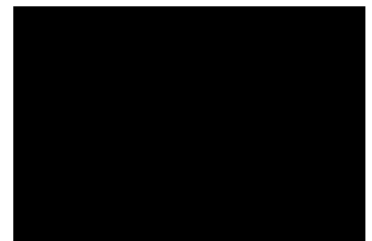

**Re: Formal Objection to the Application to Vary the Premises Licence – The Dodford Inn, Dodford**

We write to formally object to the application made to vary the Premises Licence for the Dodford Inn. We do so as local residents living on Whinfield Road, approximately 125 metres from the premises, with only a small field separating our home from the site.

The proposed variation includes:

- Extending the hours for the sale of alcohol to midnight on Sunday through to Thursday (in line with current Friday and Saturday hours),
- Extending alcohol sales from 10am daily,
- Removing the current restriction preventing the use of the outside terrace and patio after 11:20pm,
- Extending the licensed area to encompass the entire site.

We object to the application on the grounds of **public nuisance**, one of the four licensing objectives under the Licensing Act 2003.

**Existing Disruption**

Under the current licence, the Dodford Inn is already a regular source of late-night noise from private events that are mainly held on Fridays and Saturdays. We frequently experience:

- Loud music (particularly bass-heavy amplified sound),
- Shouting, cheering, and other noise from guests using the outdoor space,
- General disturbance associated with large gatherings and alcohol consumption.

The noise can be clearly heard from within our bedroom with our windows closed.

While this already impacts our ability to enjoy peace in our home, it is currently mitigated to some extent by the existing curfew on use of the outdoor areas after 11:20pm, and by the limitation that such events are typically held only on Friday and Saturdays as these are the only days the licence runs until midnight.

**Likely Impact of Proposed Changes**

The proposed changes would allow similar events to take place **any day of the week**, with alcohol sales continuing until **midnight** with no restriction on its consumption thereafter. This together with the proposed lifting of the restriction on the terrace curfew time of

11:20pm and the proposed extension of the licenced area would mean **louder disruption throughout the site and even later into the night**. This would dramatically increase the frequency and severity of the disturbance we already experience.

There is a clear risk of **cumulative impact** on nearby residents' amenity, wellbeing, and sleep – particularly given that the property is located in a rural, quiet area with limited ambient noise to mask event-related disturbances.

We believe this would constitute a **significant and ongoing public nuisance**, as defined by:

- Excessive and unreasonable interference with the comfort and convenience of nearby residents,
- A clear risk to public health and wellbeing through sleep disruption and stress.

We are also concerned that the Dodford Inn is in close proximity to The Dodford Children's Holiday Farm, a long-established charity that provides day and residential visits for children, many of whom may be vulnerable or have special needs. The charity works with schools, social workers, health visitors and other referral agencies, to give children from deprived areas that much needed break and a 'breath of fresh air' (Vision taken from the charity website). **The proposed increase in late-night noise and disruption could significantly affect the wellbeing and experience of these children.** The children's farm is sited directly opposite the pub premises on Warbage Lane.

## **Request for Refusal**

We respectfully urge the Licensing Authority to **refuse the application** to vary the licence on the basis that it undermines the objective of preventing public nuisance. The current restrictions provide a reasonable balance between the business's operations and residents' rights to peaceful enjoyment of their homes. The proposed changes would remove that balance.

We are writing to formally object to the application for a variation of the premises licence for the Dodford Inn, Whinfield Road, Dodford B61 9BG, submitted under the Licensing Act 2003.

We live at [REDACTED], Alfred's Well, and are regularly affected by noise from events held at the Dodford Inn. Even with the current licence conditions - where alcohol can be served until midnight only on Friday and Saturday nights and the outdoor terrace must be vacated by 11:20pm - we are often disturbed by loud music and party-goers. The noise can be clearly heard both inside our home and when we are in the garden. The noise is much louder when the terrace and outdoor areas are used.

The proposed variation would significantly increase the level and frequency of disruption by:

- Encouraging private events on any day of the week. The potential extension of the licence until midnight on any day would support private functions and parties bookings in the week.
- Permitting alcohol sales until midnight every night would encourage prolonged activity and late-night noise, guests could also continue to drink and party after the closing of the bar.
- Removing time restrictions on the outdoor terrace and patio, meaning noise from outdoor gatherings could continue unchecked late into the night.
- Extending the licenced premises area to the entire site would encourage further use of the outside areas – with these areas being those from which the loudest noise travels.

These changes would result in an unacceptable increase in noise nuisance. We have a young daughter who finds it difficult to sleep when music and guest noise carries from the outdoor areas—her bedroom faces the direction of the venue, and the sound often penetrates into our home even with windows closed.

In addition, we avoid inviting friends or relatives over when events are taking place, as the atmosphere is often spoiled by intrusive noise that undermines the peaceful setting we value in Dodford.

We strongly believe that granting this variation would harm the quality of life for local residents, particularly families and those living in close proximity to the venue. We therefore respectfully urge Worcestershire Regulatory Services to refuse this application.

We are writing to formally object to the proposed variation of the Premises Licence for the Dodford Inn.

We live at ■ Malvern Cottages, one of the four semi-detached cottages directly adjoining the front of the Dodford Inn premises. Our garden backs onto the pub car park. We moved to this area to raise our young family in a peaceful, rural village environment and are proud to be part of the Dodford Conservation Area.

We are particularly concerned about the proposed changes, which would:

1. **Extend the licensed hours until midnight every night**, not just Friday and Saturday as currently permitted. This will increase the number of private events that are likely to be held in the week in addition to those that tend to take place on a Friday and Saturday.
2. **Remove existing restrictions on the use of the patio area**, which currently limits use and must close by 11:20pm.
3. **Extend the licensed premises area to the entire site**, rather than being limited to the building's immediate vicinity.

These proposed changes, if granted, would significantly increase the frequency and duration of noise and disturbance impacting our home and family life.

As parents to two small children (ages 3 and 4) with a third child due imminently, the potential for additional late-night noise is extremely worrying. The current weekend noise already disrupts their sleep, particularly in warmer months when doors are open and party-goers gather outside. We often have to keep windows closed to reduce the impact, making summer nights uncomfortably hot. An extension of hours and removal of outdoor restrictions would only intensify these disturbances.

Additionally, I work full-time as a lift engineer and leave home by 6:00am. A restful night is essential to both my wellbeing and the safety of my work.

The proposal to license the full site for alcohol sales - including the potential for outdoor bars or pop-up drink stands - poses further concern. Increased outdoor activity and noise in the grounds, directly adjacent to our garden where our children play, would concern us for their safety and possibility of being exposed to inappropriate language and behaviour.


This application represents a significant shift from the pub's current operation. We didn't object to the planning application to change the pub's use to include use as a

wedding venue. We have a good relationship with the pub owners and visit the pub as customers. However, we now feel that we have to object to this Premise Licence variation as it feels that there are no boundaries - alcohol served until midnight every night, no time restrictions on outside use and the extension of this outside area to include the whole grounds feels unreasonable and not working in partnership with the local villagers. It is not in keeping with the rural character and conservation values of Dodford nor supporting the rural and peaceful life that the village enjoys.

We respectfully ask that the licensing authority considers our concerns, raised under the licensing objective of preventing public nuisance, and the negative impact this would have on neighbouring families and local villagers. We would ask them to reject the proposed variation to the Premise Licence.

Good evening,

I am writing with concern regarding the application to vary a premises licence or club premises certificate under the licensing act 2003 at the Dodford Inn, Whinfield Road, Dodford, B61 9BG.

As a regular visitor to the pub, and have been for many years, I am very much in support of the family to continue to run a successful business. What already seems to be a thriving wedding venue, it doesn't seem to have any issues with the current hours in place, with regular weddings and parties.

I do not have an objection with the serving hours to begin at 10am, I think this is a lovely way for visitors to enjoy their special day.

A few points I am concerned about, as a village resident, if I were to have my wedding reception at Dodford village hall, this has a cut off time for music at 11.20pm unless a TEN is applied for. Regarding the extension of the music times to 00:00, if this is to be granted I hope this can be managed in a way against nuisance for neighbouring properties. My concerns are how this will impact our small, quiet, conservation village life and the surrounding properties of the pub.

Weeknight noise is a huge concern of mine. Being so close to the venue, we are very much impacted by the noise and how this can impact rest for work. Previous weddings have been heard inside the house even with doors and windows closed.

Perhaps a noise monitor could be installed, like Dodford Village Hall is required to have for neighbouring properties sakes. With future planning for a family, I don't wish for this to affect my family home and leave me unable able to open windows. Two of my neighbours also have young children and Dodford Children's Farm is directly opposite Whinfield Road where young families regularly stay.

My unease also lies with the complete removal of time restrictions for outside areas particularly with the extension of the boundaries, meaning it will be up to the bottom of my garden. I feel it isn't necessary to allow people to be so close to neighbouring properties to drink and be loud. I appreciate you can't control people's actions when leaving the venue, as it currently stands as a car park, I am just unable to understand the reasoning behind the boundary extension and what this will mean for the future, particularly if anything was to be

placed such as food vans, having festivals on the field etc and how this could impact on privacy.

The venue has also created a noticeable amount of traffic within the village, raising particular concern as to the speed at which people drive down Whinfield Road when going to the venue. I understand that this is not something that is directly relevant to the application, though is a concern that I have.

I do hope that my concerns are able to be considered towards the application as well as the wider concern of local residents.

Whilst I understand the need for a business to grow, it should not be at the detriment of others, neither financially (property values) or well being.

By extending the licensing hours and the permitted area in which to sell and consume alcohol 7 days a week for parties and weddings, would be inappropriate in such a rural location. Already the music travels across the fields and valley, and the venue is in extreme close proximity to several houses.

It is accessed by single track lanes in each direction, thus the traffic leaving in the early hours of the morning would be of significant disturbance to the surrounding village properties.

In conclusion, the proposal would fall into the category of public nuisance
