INFORMATION FOR THE PUBLIC

Access to Information

The Local Government (Access to Information) Act 1985 widened the rights of press and public to attend Local Authority meetings and to see certain documents. Recently the Freedom of Information Act 2000 has further broadened these rights, and limited exemptions under the 1985 Act.

- A reasonable number of copies of agendas and reports relating to items to be considered in public will be made available to the public attending meetings of the Council, Cabinet and its Committees/Boards.
- You have access to a list specifying those powers which the Council has delegated to its Officers indicating also the titles of the Officers concerned, as detailed in the Council's Constitution, Scheme of Delegation.

LICENSING SUB-COMMITTEE (Premises)

HEARING PROCEDURE

1. The Chairman will open the hearing and ask Members of the Sub-Committee and officers present to introduce themselves.
2. The Chairman will ask all parties to the proceedings to introduce themselves.
3. The Chairman will ask all parties if they are satisfied with the hearing procedure to be followed. Any variation to the hearing procedures will be at the discretion of the Chairman.
4. The Technical Officer (Licensing), Worcestershire Regulatory Services will present the report.
5. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Technical Officer.
6. The Chairman will invite the Applicant and/or their representative to present their case and call any witnesses. A total of 15 minutes will be allowed.
7. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Applicant and/or their representative.
8. The Chairman will invite the Responsible Authorities to present their representations. A total of 15 minutes will be allowed.
9. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Responsible Authorities.
10. All Other Parties to the proceedings will be invited to present their representations or elect a spokesperson to speak on their behalf. A total of 15 minutes will be allowed.
11. The Chairman will invite Members of the Sub-Committee and all parties to the proceedings to put any relevant questions to the Other Parties.
12. The Responsible Authorities will be invited to sum up. A total of 5 minutes will be allowed.
13. The Other Parties will be invited to sum up. A total of 5 minutes will be allowed.

Appendix

14. The Applicant and/or their representative will be invited to sum up. A total of 5 minutes will be allowed.
15. The Chairman will ask the Legal Advisor if there is any legal advice to be given.
16. The Chairman will close the Hearing so that the Sub-Committee can reach its decision in private.
17. The Sub-Committee's decision will be confirmed in writing to the Applicant and those parties who made representations within 5 working days.
18. If any party to the proceedings wishes to appeal against the Sub-Committee's decision an appeal must be commenced by the appellant giving a notice of appeal to the designated officer for the magistrates' court within a period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision which is being appealed.

In considering any representations or notice made by a party the Sub-Committee may take into account documentary or other information produced by a party in support of their application, representations or notice either before the hearing or with the consent of all other parties at the hearing.

1. PURPOSE OF REPORT

- 2.1. To consider and determine an application for grant of a premises licence in respect of

- 2.2. A copy of the application is attached at Appendix 1.

3. BACKGROUND

- 3.1. On 21 July 2025 an application was received from RB Retail and Licensing Services Ltd on behalf of Mr Kenneth Frederick Moore & Mrs Sarah Louise Moore for grant of a premises licence in respect of Thornborough Events

Thornborough Farm, Redhill Road, Kings Norton, Worcestershire, B38 9EH.

- 3.2. The application contained all the requisite documentation including the fee and a plan of the premises.
- 3.3. It can be confirmed that the application has been advertised in accordance with the requirements of the Licensing Act 2003 and associated regulations and that the application has also been served on all responsible authorities.
- 3.4. The applicant is applying for the following licensable activities:

- 3.5. The application has also proposed the following Non-Standard Timings:

A privately booked event such as a wedding etc and utilising one or more of the licensing activities applied for within this application could be held on any day of the week.

Guest numbers will be limited to 200 persons.

This event will be included within a 28 days per year from 1st May to 30 September proposed to a limit.

- 3.6. The designated premises supervisor identified in the application is Mr Kenneth Frederick Moore.
- 3.7. Office records indicate that several previous events involving the sale of alcohol, regulated entertainment and late night refreshment have taken place at this site address which were authorised by way of Temporary Event Notices. The details of the Temporary Event Notices authorised for the site address are as follows:

- 2021 - Two TENs
- 2022 – Two TENs, one TEN was withdrawn prior to the event.
- 2023 – Six TENs
- 2024 – Thirteen TENs,
- 2025 – Ten TENs

- 3.8. Office records further indicate that there were two complaints regarding the levels of noise at the premises received by the council in June 2024.
- 3.9. Between June 2021 and August 2025 eighteen complaints have been logged by local residents with the Environmental Health noise pollution team regarding noise levels emanating from the premises.

4. REPRESENTATIONS RESPONSIBLE AUTHORITIES

- 4.1. The application has been forwarded to all responsible authorities prescribed under the Licensing Act 2003.
- 4.2. In response, Worcester Fire and Rescue Service submitted a representation requesting the following:

*Receipt of the above application is acknowledged and from the information provided the Fire Authority has no objection to the grant of the premises licence, **providing an Event Management Plan is submitted to the relevant authorities and advisory group.***

- 4.3. The authorised applicant agent has since agreed for the additional condition to be included on the licence when issued.
- 4.4. Environmental Health have also submitted a representation, and having assessed the application have requested for additional conditions to be attached to the licence. These cover the number and spacing of events to address concerns relating to public nuisance, the conditions requested are as follows:

- 1. *Number of events with between 201 and 4000 attendees be limited to 11 days in total, not on consecutive weekends and a maximum of two consecutive days and only on one of the two Bank weekends in May to include the Bank Holiday Monday.*
- 2. *Number of events with attendees up to and including 200 (referred to in the application as weddings) to be limited to 5 days in total, no more than one day per month during the period requested in the application, to be held during the week (as indicated on the application).*
- 3. *That for each event expecting 201 to 4000 attendees that an Event Management Plan be submitted to and agreed by WRS (acting on behalf of Bromsgrove District Council) at least 3 months beforehand.*
- 4. *That a noise management plan is to be prepared and agreed with WRS and implemented for the site to cover all events.*

5. *No category F3 and F4 Fireworks to be used on site.*
 6. *That the sections of the application for the provision of late night refreshment is not granted as this would encourage attendees to remain on site after the entertainment stops with the potential to cause noise nuisance.*
 7. *That the section covering recorded music and live music is clarified and if the application is in effect for 24 hours between Monday and Friday that this is limited to 12:00 to 23:00.*
- 4.5. The above conditions have been agreed with the applicant via the authorised agent, should a licence be granted these conditions will be included on any premises licence issued.

OTHER PERSONS

- 4.6. In responses to the public consultation and site notice, a total of 49 representations were received by the council in relation to the application. 28 representations were received from persons opposing the application and 21 representations were received from persons in support of the application.
- 4.7. Of the representations received objecting to the grant of a premises licence, concerns were raised of the potential for public nuisance, crime and disorder and public safety. A copy of these representations are attached at **Appendix 2**.
- 4.8. Video evidence has also been submitted by one of the objectors, highlighting the impact of noise levels from music events on nearby residential properties. A copy of the videos will be made available at the hearing.
- 4.9. Of the representations received supporting the grant of a premises, individuals stated that based on previous events held on site the applicant has demonstrated that they would actively promote the licensing objectives, by managing events responsibly. A copy of these representations are attached at **Appendix 3**.
- 4.10. It should be noted that 5 further representations were received by the council in support of the application. However, upon review of these submissions, 4 of the representations were deemed not to be valid and 1 letter was submitted with illegible name and contact details.

5. LOCAL POLICY CONSIDERATIONS

- 5.1. The Sub-Committee should have regard to the Council's Statement of Licensing Policy under the Licensing Act 2003.

6. LEGAL IMPLICATIONS

- 6.1. The Sub-Committee is obliged to determine this application with a view to the promotion of the licensing objectives which are:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance;
- the protection of children from harm.

- 6.2. In making its decision, the Sub-Committee is also obliged to have regard to the guidance issued by the Secretary of State under section 182 of the Licensing Act 2003 and the Council's own Statement of Licensing Policy.

- 6.3. The Sub-Committee must also have regard to the representations made and the evidence it hears.

- 6.4. The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- (a) Grant the application as requested
- (b) Modify the conditions of the licence, by altering or omitting or adding to them.
- (c) Reject the application in whole or in part.

- 6.5. The Sub-Committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

- 6.6. All parties to the hearing will be notified of the Sub-Committee's decision in writing within five working days of the conclusion of the hearing.

- 6.7. Any party aggrieved by a decision taken by the Sub-Committee may appeal against the decision to a Magistrates' Court within 21 days of being notified of the decision in writing.

- 6.8. The hearing should be conducted in accordance with the agreed procedure.

7. FOR DECISION

- 7.1. The Sub-Committee must consider and determine the application.

THE PREMISES CONSISTS OF AN OPEN FIELD ON GROUND UNSUITABLE FOR CROPS OR GRAZING (EXCEPT DURING THE WINTER MONTHS).

THE FIELD HAS HAD GRANTED IN EXCESS OF 40 TEMPORARY EVENT NOTICES (TEN's) SINCE THE SUMMER OF 2021. THE APPLICANTS WISH TO REGULARISE THE POSITION TO REMOVE UNCERTAINTY REGARDING FUTURE EVENTS AND INCREASE POTENTIAL VISITOR NUMBERS TO A MAXIMUM OF 4000 PERSONS.

THE EVENTS INVOLVE VARIOUS MUSIC FESTIVALS, FAMILY FUN DAYS, VINTAGE MOTOR RALLYS AND OTHER GATHERINGS OF A SIMILAR NATURE. THE EVENTS WILL ONLY TAKE PLACE BETWEEN MAY AND SEPTEMBER AND LAST ONE DAY OCCASIONALLY TWO/THREE DAYS WITH AN OVERSPILL FIELD PROVIDING SPACE FOR VISITORS TO ERECT THEIR TENTS, SUFFICIENT TOILETS, A SHOWER TRAILER, CAR PARKING AS WELL AS OTHER FACILITIES MADE AVAILABLE ADJACENT TO THE OVERSPILL FIELD.

TO DATE ONE TEN APPLICATION WAS REFUSED BUT WAS RESUBMITTED AND ACCEPTED DUE TO AN ERROR ON THE APPLICATION FORM, A SECOND TEN APPLICATION HAD BEEN WITHDRAWN BECAUSE OF POOR VISITOR TAKEUP. THE REMAINDER HAVE ALL PROCEEDED WITHOUT ISSUE. NOISE COMPLAINTS HAVE BEEN RECEIVED BY THE NOISE POLLUTION TEAM ON A FAIRLY REGULAR BASIS AND NOISE MONITORING EQUIPMENT HAS BEEN INSTALLED IN THE COMPLAINANTS HOME FOR SOME TIME COVERING RECENT EVENTS. THE RESULTS HAVE NOT WARRANTED FURTHER EH INTERVENTION.

EVENTS NORMALLY FINISH AT 23.00 HOURS. LOCAL AUTHORITY STAFF/POLICE REGULARLY VISIT THE SITE ON EVENTS DAY AROUND CLOSING TIME TO CHECK ON THE EVENT AND HAVE FOUND NO ISSUES.

TICKETS TO THE EVENTS ARE PURCHASED ONLINE IN ADVANCE AND THERE IS NO ADMITTANCE ON THE DAY. NUMBERS ARE CONTROLLED WITH A COUNTING DEVICE AT THE ENTRANCE TO THE SITE.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

1. The Premises Licence Holder shall ensure that all staff employed at the premises whose duties include the sale or supply of alcohol shall undertake and complete a relevant programme of internal training prior to them being authorised to sell or supply alcohol.
2. The premises licence guidance manual will be the basis of alcohol sales training.
3. Records of the training programme shall be maintained and made available to Authorised Officers upon request.
4. The Premises Licence holder shall provide a “refresher” training session to all relevant staff members as and when deemed necessary on a case-by-case evaluation, but as a minimum requirement the refresher training session shall be provided to all staff on at least one occasion every twelve months.
5. The CCTV policy shall incorporate the following basic requirements:
 - Be switched on and fully operational when the licensable activities are being carried out.
 - Record for a minimum rolling period of 31 days
 - Have a means of copying any footage to another medium as evidence if requested by the Police.
6. CCTV cameras will be located in consultation with the Police or crime prevention officer prior to the event but as a minimum, cameras will be located within the bar lorry, and on the music lorry, the marquee and on an appropriate external toilet location all aimed towards the seated and standing areas around the bar and music lorries. The CCTV monitor and hard drive will be located within the bar lorry.
7. Warning notices advising visitors that CCTV cameras will be recording around the event field.
8. All members of staff at the premises shall seek "credible photographic proof of age evidence" from any person who appears to be under the age of 25 years and is seeking to purchase alcohol for consumption on/off the premises. Such credible evidence will include a passport, photographic driving licence, or a Proof of Age card carrying a "PASS" logo.
9. A refusal log will be kept at the bar and be maintained to record the refusal of alcohol beverages to underage or intoxicated persons. The details collated will include a description of the individual refused, the date and time, the details of the product refused, the reason for refusal and the name of the staff member
10. Prominent, clear notices shall be displayed at all exit points to advise customers to respect the needs of local residents and of acceptable behaviour in public spaces and when leaving the premises field and area to do so quietly.
11. An appropriate number of SIA registered Door supervisors shall be on duty for the length of the event and until the dispersal policy is completed for any event that a risk assessment deems it to be necessary and appropriate.
12. Local taxi firm information is to be available at the premises.
13. There will be a half hour drinking up time following the each days stated terminal

14. Live and recorded music will cease by 23:00 hours on a Friday or a Saturday and by 22.00 hours on a Sunday.
 15. Where regulated entertainment is provided, the premises licence holder (PLH) or designated premises supervisor (DPS) or a responsible person (RP) nominated in writing will regularly monitor noise recorded or live music emanating from the premises to ensure that noise levels are reasonable and unlikely to become a nuisance and will make necessary adjustments to reduce volumes or bass where necessary.
 16. A written record shall be kept on the premises detailing the name of the person carrying out the monitoring, the monitoring locations, the date and time of the monitoring and the result obtained.  19. Appropriately sized signage stating no consumption of alcohol not purchased on site is permitted. These notices will be displayed prominently on the Event field site, at the entrance to the site from the highway (Redhill Road) and at the alcohol point of sale as well as the overspill field (when used).
 20. A risk assessment otherwise known as an Event Management Plan (EMP) will be made prior to an event to identify measures required for the safety of staff and patrons. This will include emergency medical care, sufficient toilets to cater for anticipated event attendance, lost child facilities, traffic wardens, security staff, marked visitor parking with parking staff to guide visitors, separate disabled parking area, litter patrol, dedicated refuse storage area & visitor help desk. The risk assessment will be provided at least 3 months before the event to the Bromsgrove safety advisory group (Police, EH & Licensing) or if the event is arranged at shorter notice no later than 4 weeks before the event.
 21. A dispersal policy will be included with the risk assessment.
 22. A zero tolerance to drugs policy will apply particularly to any events that include use of the overspill field for overnight stays.

A single named point of contact (PC) plus telephone number will be publicised on the event website, so that local residents can report any noise issues or other complaints directly to the organisers. All calls will be logged by time by the PC. Details of the caller will be requested by the PC to include their location/address and contact number. The log will include a note of the remedial action taken. The log will be kept on the premises and be made available upon request for inspection by an officer of a responsible authority or a Police Officer.
 24. Between 1st May and 30th September each year there will be no more than 28 days of event activities. Events will be limited to just Friday to Sunday except for small privately booked events such as a wedding reception etc which would

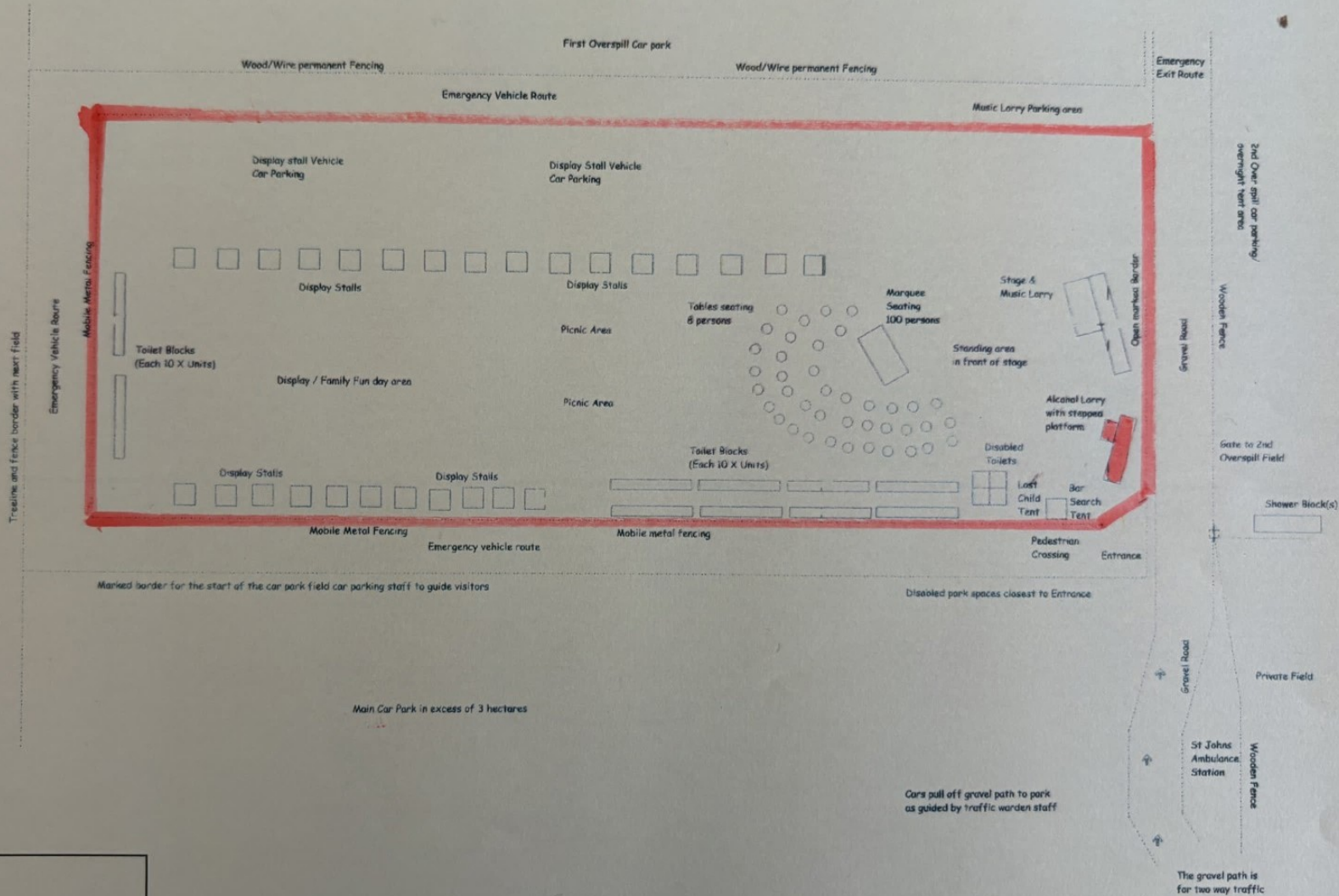

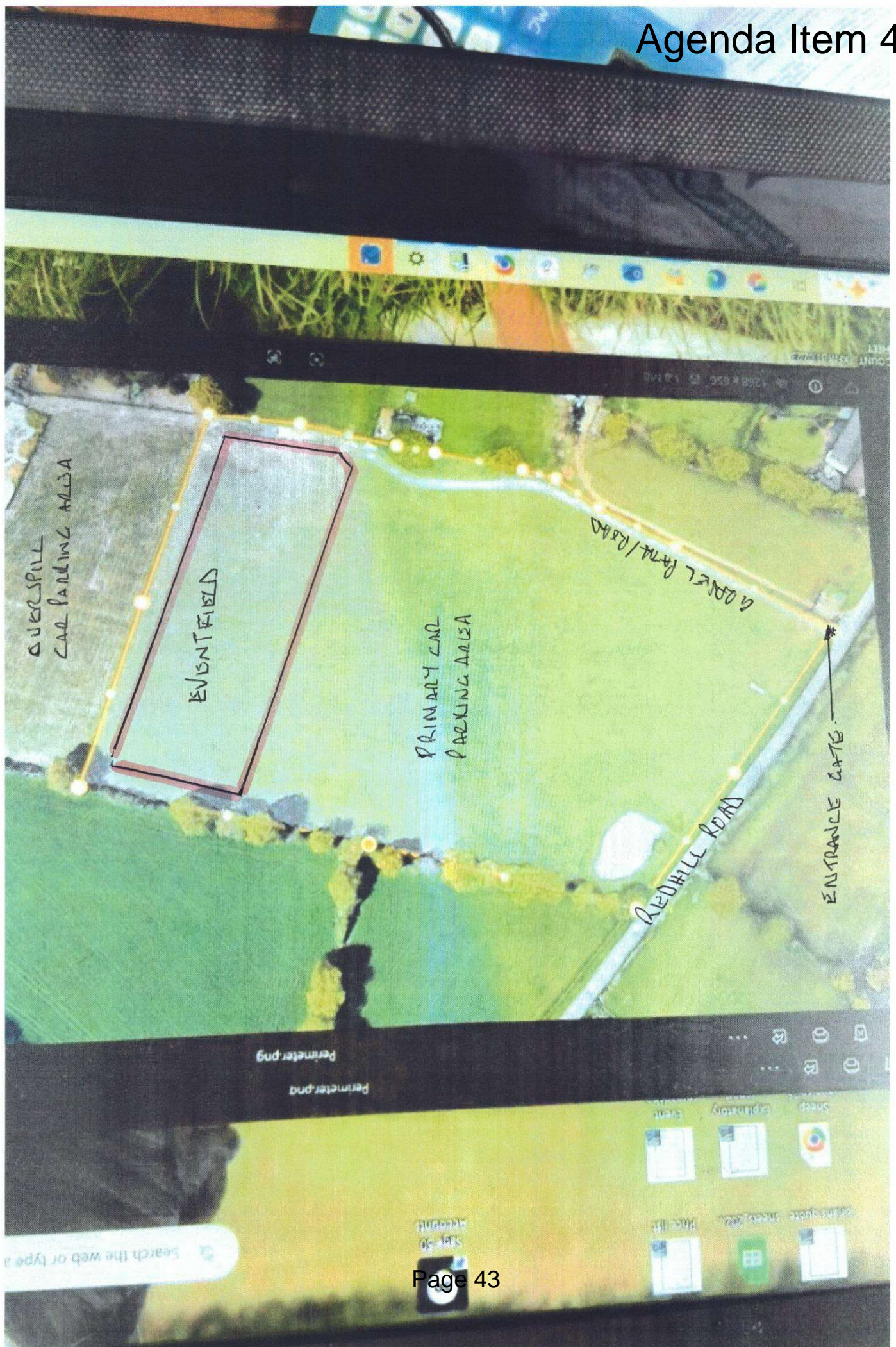

I am writing to formally object to the planning application for Thornborough Farm, Redhill Road, Kings Norton, B38 9EH (REF 25/03508/PREMLI) which proposes to convert the site into a ongoing entertainment venue potentially operating regularly on Fridays, Saturdays and Sundays, with extended hours until midnight!

As a nearby resident, I already experience significant disruption from the eight or so events currently held at the venue each year. Many local households complain each time these occur, and it's surprising even those events are still allowed to operate due to the disruption.

On each occasion, loud music and amplified sound travel directly towards our property and continue until at least 11pm, severely impacting our ability to enjoy our home and get adequate rest.

The proposal to make this a regular occurrence, increasing the frequency and extending the hours, raises serious concerns. The cumulative effect of weekly events, especially running until midnight, will substantially increase noise pollution and disturbance to the local community. The rural character of the area is not suited to this level of commercial entertainment activity.

I am writing on behalf of myself and my daughter (who will be moving in with me on 8th August) to formally object to the recent application for a premises licence under consideration by Bromsgrove District Council, relating to Thornborough Farm, Redhill Road, Kings Norton, Worcestershire, B38 9EH.

My address is [REDACTED] which is in close proximity to the proposed premises. Our primary concern relates to the prevention of public nuisance, which we believe is one of the four licensing objectives under the Licensing Act 2003.

The proposed activities, which we understand include the provision of alcohol and entertainment, have the potential to generate significant noise, particularly during the evening and late-night hours. Given the residential nature of the area, this is likely to cause substantial disturbance to local residents, including myself and my daughter and also my Autistic Grandson who stays with us on a regular basis.

Our home is situated within direct hearing distance of the premises therefore any amplified music, particularly thumping/vibration from the music could severely impact our quality of life—especially at night when noise travels more readily and can disrupt sleep.

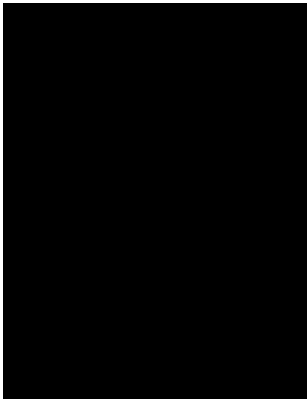

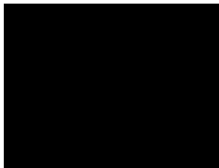

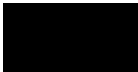

I am writing to formally object to the application for a Permanent Premises Licence for Alcohol and Entertainment at Thornborough Farm, Red Hill Road.

As a local resident, I have serious concerns about the negative impact that this licence would have on our community and the peaceful rural character of the area. Recent events held on this land have already caused significant disturbance and upset to those living nearby.

My specific concerns are as follows:

1. Excessive Noise

Events at the site have involved loud music and amplified sound carrying on late into the night. This has disrupted the peace and quiet that we expect and value as part of living in a rural area. On more than one occasion, it has felt as though a festival is taking place, with noise travelling a considerable distance and making it impossible to relax or sleep in our own homes.

2. Security Issues

The events do not appear to have proper security arrangements in place, which raises concerns about the safety of both attendees and nearby residents.

3. Litter

There has been a noticeable increase in rubbish and waste in the surrounding area following events, which is unsightly and harmful to the environment.

4. Traffic

The increased volume of vehicles on narrow rural roads poses a danger to both drivers and pedestrians. These roads are not designed for high traffic volumes, particularly during events.

5. Anti-Social Behaviour

There have been incidents of rowdy behaviour, drunkenness, and loud shouting which have made the area feel unsafe and unpleasant for residents.

6. General Disruption

The activity associated with these events—music, traffic, groups of people, and lighting—represents a significant intrusion in what should be a quiet, countryside setting. It is unfair to expect local residents to tolerate such disruption on a regular basis.

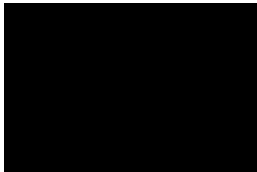
7. Negative Impact on Property Values

We object for the following reasons

1. Over the past three years, the applicants have proven to have a complete disregard with no consideration for residents in the surrounding area. We have been subjected to unpredictable outbursts of noise. An Outdoor cinema, football match screenings, circus, car boot, 12.45am “soundcheck” and festivals/loud outdoor music events on a frequent basis
2. With events that took place on TENS licences throughout 2024 the applicants did not comply to the parameters outlined within the TENS granted (substantiated), which demonstrates an irresponsible licence holder in not adhering to the curfews granted in the TENS and playing music above 80DB.
3. In 2024, we were subjected to FOURTEEN loud events, a total of NINETEEN full day and nights disruption. (Two events on the adjoining Happyfields, same landowner). We’ve spent the last three summers praying for rain, in the hope events would be cancelled.
4. Using the history of behaviour as a guideline I.e. the noise and disruption from this site, with and without the TENS permits, it would suggest that the applicants are not suitable candidates to hold a Premises licence. In addition and relation to this Premises application, on Monday 4 August 2025, I contacted various parties as the applicants had not displayed the Application from 1 August 2025 on site as required by law. Later that day, the Application was displayed in the corner of the field, on the opposite side to the entrance, in scrub and brambles where it was barely visible to the public. Tuesday 5 August 2025, the applicants were more transparent and have displayed the application on the main gate.

5. Currently due to the frequency of “events” granted on TENS the site is causing significant stress, destroying our lives, to the point of needing to sell the house which we’ve worked so hard for, we are essentially being driven out of our home.

6. This is an OUTDOOR venue which means there is nothing in place to block the excessive noise, coupled with it being a rural area, there are no buildings to buffer the noise away from our homes.

7. For over five months of the year (summer months), we cannot enjoy our garden or home and go to bed every weekend listening to somebody else’s music. We try to avoid staying here at weekends, which is unacceptable, especially when we have animals and land to look after. This application is to include working weekdays May-September, this will now encroach on our working week and affect the performance of our jobs

8. It has impacted our mental health, our quality of life, our lifestyle and that of friends, family and neighbours.

9. Friends and family no longer wish to spend weekends at our home, due to the frequency of festivals and having to listen to someone else’s music whilst visiting.

10. On occasions we and other neighbours have been so desperate for the noise to abate, we have contacted the police.

11. We purchased in this Greenbelt area mainly for the purpose of peace and quiet. We did not choose to buy a house next to a loud entertainment venue.

12. A permanent venue would impact the openness of the Greenbelt

13. It is a Change of Use from an Agricultural field without permission.

14. The owner has continually flouted Planning regulations and TENS guidelines (substantiated).

15. The entrance/exit is located on a national speed limit road. We have witnessed taxis pulling onto the verge, arriving and leaving the field disrupting the flow of traffic in a dangerous manner. This is an unsuitable location in the interest of Public Safety.

16. Previous actions and activities on this agricultural field have not fallen within Permitted development rights or any Planning rights exceptions, this has shown a complete disregard for Planning laws. It is now mainly used for entertainment purposes.

17. We initially complained about disruption from this site over THREE years ago, on 20 April 2022 to Dale Birch Bromsgrove District council. I have since sent numerous emails and evidence of disruption to WRS (mainly Dave Etheridge) Bromsgrove Planning, Councillors, Wythall Parish Council, West Mercia Police, Bradley Thomas MP, North Worc. Licensing and have also along with other neighbours contacted 101 in a desperate attempt to make the noise abate.

18. PC Stuart Head has been my main contact at West Mercia Police and is fully aware along with others, of the upset this site has caused over the years.

19. We already have an existing Sports club in the immediate area that have increased their outdoor social events in the past three years, if another venue is allowed to go ahead we will have no respite from noise and music throughout the whole year. It is currently relentless.

20. We have two local pubs, although this venue proposal would also offer entertainment in addition to alcohol, it would potentially take trade from an already declining industry, pubs are currently closing at an average of six per week.

21. Other than financial gain for the owners, I see no benefit to the local area, local business' or the Greenbelt.

22. The applicants have taken advantage of the system and outdated legislations for many years

The activities on this field are unreasonable and substantially interfere with the use and enjoyment of our home, to the extent of affecting our health. Given the disruptive nature of this site over the years and the unpredictability of the applicant, the site has proven to be a Public Nuisance, therefore we would deem this site and candidate unsuitable to be considered for a permanent entertainment venues and Premises licence.

I am emailing with reference to the attached licence request for the Thornborough Farm Events. I live at [REDACTED] and have lived here for 11 years. I wish to object to the proposed licence application on the grounds that this presents a nuisance and the venue, which I believe to be classed as agricultural land is not an appropriate venue for such activities.

Background

We became aware of the increased use of temporary notice event licences issued to the above venue in 2023 and during the summer of 2024 lodged numerous complaints regarding the frequency of events and the noise level during the summer months. I was in regular contact with your office during last summer and had contact with Toby Hardman Dodd and Dave Etheridge from your office.

One of the issues was the number of events when the venue was booked by different organisations which meant that TENS were issued for the same property which I expect made it difficult to track the actual number granted. This meant that there were events over most weeks in the summer.

Our property has no natural sound barriers such as trees or hills to break the sound and as such are probably more impacted than most properties in the area. We have a garden terrace directly behind our wall which we wish to sit out and enjoy in the summer, however this is disrupted by music on many occasions. It sounds like the music is in our own garden. During 2024 there were at least 14 events at the venue and these were on weekends when we would normally expect to be able to enjoy our garden during the daytime. In the night the licences were granted on some occasions beyond the 11pm curfew.

We frequently have young grandchildren staying with us, afternoon naps and bedtimes are affected if this coincides with an event.

I question if this application indicates a change of use and needs to be reviewed by the planning department. The temporary nature of the infrastructure installed for the summer I am sure complies with regulations and I note that the fields do have animals in during the other months. However, it has to be questioned if this is really an acceptable and appropriate use of rural agricultural land.

The attached licence is for 28 days over a period of 5 summer months, and restricted in the main to weekends, this means that out of 48 days a large proportion of them may be affected by noise disruption. This also is a vast increase on the current level of usage.

In 2014 we moved from Moseley to our current property, choosing to pay a premium to live in the peaceful countryside and greenbelt and to accept the restrictions this has on any planning applications we would make, it seems unreasonable that we are now faced with the possibility of a licenced festival venue with up to 14 weekends out of 22 with noise disruption. This may also be extended to midweek private events.

During 2024 I had a number of text exchanges with Sarah Moore (all available if needed) 2nd June 2024 regarding an external letting event which went on to 1 am 20th July sent at 27 minutes past 12 am which related to a sound check

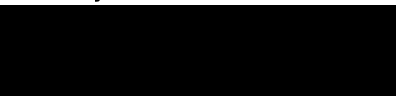
I have copied and pasted information from the venue website below which indicates the intention to host events for a few thousand but the requested licence is for 200 for private events.

The impact of the growth of this venue has directly affected my mental health and that of my neighbours, as we are a very small community and unlikely to be able to mount a significant campaign I believe those of us who have been affected have been unable to date to prevent the expansion and inappropriate use of this site.

In addition to the noise disruption I am concerned about the rise in traffic and safety on a busy stretch of the Redhill Road, with extra traffic from Birmingham likely to use Icknield Street as a short cut. These lanes are not designed to cope with such usage.

The sale of alcohol at such events and the potential for drug abuse is also a concern, we witness drug exchanges on the lanes already and with the possibility of potential 'customers' attending festivals in the vicinity we can only assume this will also rise.

I would appreciate an acknowledgement of receipt of this email.

I have been given your email address by my neighbour [REDACTED] because I gather you are looking into the noise disturbance we are experiencing as a result of the expansion of activities by Thornborough Farm Events.

I live on [REDACTED] directly in line of the sound which carries over the 2 fields separating our property to Thornborough. I have previously been in touch with Dave who I have copied in to this email.

My concern is the frequency of events licenced under Temporary Events Notices and the noise level of these events. On Saturday I recorded 2 videos which demonstrate both volume and excessive sound after published curfew of 10pm. These are available to you although I am struggling to attach them to this email. Can you give me a mobile number I can send them to via whatsapp. There seems to be a discrepancy between published event times and actual licence agreement. As local residents are not

consulted, we have no information other than the web site to be guided by and so are frequently surprised when events appear to overrun.

I am also concerned by the regular disruption during the daytime which now is impacting on our enjoyment of the peace in our garden. We are sparsely populated and as such our greenbelt neighbourhood is unlikely to be able to mount a huge number of complaints. However the impact of the expansion of this once agricultural land to a permanent music venue is surely not compatible with the health and wellbeing of our community.

I would welcome noise recording equipment at my address so the level can be monitored more accurately and for a full investigation to the use of this land and issuing of licenses that enable this activity to continue.

Please find attached an objection to the licence application for Thornborough Farm. The main objections are as follows:

Redhill Road is, at present, a dangerous road. The speed limit is 60mph, and there have been numerous accidents in the near vicinity of the proposed venue. There are no pavements, and the nearest public transport drops off 1 mile away. This is also a rural area. There are many agricultural vehicles, cyclists and horses. An increase in pedestrians and general traffic will introduce further hazards.

We have had cars spun round in our drive, going through the fence opposite (close to Thornborough) and a recent RTC where a speeding driver was overtaking on a blind bend (the police said there was also an incident near Kings Norton golf club the same night which is the same distance the other side of Thornborough). An RAC driver was nearly killed when a driver came round the bend and drove into the vehicle he was unloading.

Safety is the primary concern, but there is also a serious issue with litter and noise - the verges are already full of bottles, cans and fast food wrappers. Late night drinking and events can only make that worse.

The noise from the events is already disruptive, and music can be clearly heard from our house. Each event being 2 days (minimum), including camping, means that the whole weekend is spoiled. We would also be interested in the child safeguarding plans in place for the family fun days that are currently advertised.

NOISES

I am writing to OBJECT to licence application 25/03508/PREMLI.

I live in close proximity the event location, Thornborough Events, at Forhill, and as such feel justified in my response below to the above licence application.

My objections are as follows:

1. Prevention of public nuisance - events held at the location already cause a public nuisance (noise nuisance), in my opinion, due to excessive noise from loud live and recorded music blasting out into the otherwise peaceful environment. I fear that extending the existing temporary licence will result in more frequent events spoiling the enjoyment of my property both indoors and outside which I feel are impacting my mental health.
2. Prevention of crime & disorder - I am worried about the potential for an increase in crime and disorder a) given the request for extending the alcohol licence and b) the development of a camping field which will be directly adjacent to the North Worcestershire way public footpath and neighbouring properties. Noise, drinking and unruly behaviour is very likely to spill out beyond the licenced period at the camping site. The area particularly the adjacent green belt is already becoming increasingly littered and I fear that there is no provision by the events company for local clear ups during and after each event.
3. Public safety - traffic turning on and off an fast main road, unlit at night, could result in a serious road traffic accident. There is no public transport adjacent to the site, resulting increased road traffic and the associated negative environmental impact. Due to absence of public transport there is likely to be an increase in drink/drug driving.

This event location is, simply put, a field located what little remains of green belt in the area, turned over to mediocre live and recorded events. It does not enhance or benefit the location or the local population and should not be permitted

Hello,

I am writing to object to the application for a Premises Licence 25/03508/PREMLI by Thornborough Events. I am a local neighbour living on [REDACTED]

After the growth in the number of events being run at Thornborough Farm last year, and the disruption through many summer weekends to my family, and other local neighbours, I contacted Toby Hardman-Dodd (Environmental Health Officer), and I was made aware of other discussions between neighbours and Dave Etheridge from Licensing, Simon Wilkes (Head of Regulatory Services) and also our MP Bradley Thomas. Initially I was unaware of how the Temporary Event Notices process worked but have now some basic understanding. The new permanent premises licence application is very concerning.

The primary issue is about noise. My home is around 400 metres away from the site, although there will be several more much closer (including properties with livestock and other animals). Several of the previous events continue to 11pm and have prevented sleep. There has been an instance of what I would call a 'late night soundcheck' outside of the permitted hours during this season. Previously I have reported that a work colleague who lives on the Alcester Road in Hollywood at approximately 2 miles could hear an earlier festival, in part due the elevated position and open aspect of the site.

The event organisers do not appear to adequately address concerns or be prepared to compromise with members of the local community. One neighbour contacted Sarah Moore, one of the organisers, directly. Among the responses was that the programme was "only 8 events in 52 weeks", which is perhaps disingenuous as in practice the events were concentrated over the summer. This could now increase again significantly with the proposed Permanent Premises licence which paves way for parties, weddings on significantly more days throughout the year. Other complaints regarding late night noise, and motorbikes, had been rebuffed (as I understand) because some events are not "directly organised" by Thornborough Events but instead had a third party responsible. Offering an octogenarian neighbour a free pass to an Ibiza weekend shows little true understanding. All of this, the varying nature of events, and additional late notice TENs applications I understand has made it difficult for the Local Authority team to take much significant action.

Obviously there is a question of balance, and there will be many different opinions and points of view. Green belt countryside is here to be enjoyed by everyone. Certainly I'd be supportive of a few events per year, similar to other outdoor festival sites. The year on year increase of events, proposed to expand further into 2026 and beyond are increasingly disruptive to the local community. Questions should be asked if this is an acceptable or appropriate use of Greenbelt land, and if both the manner of the previous TENs and proposed Permanent licence would set an unwelcome precedent to be tried elsewhere.

I sympathise with the different teams involved from the Local Authority who must deal with complaints and conflict, and I recognise that there are limits to what actions can be taken. However, from Simon Wilkes response to Bradley Thomas last year I was hopeful for a reduction in the negative impact to family life from Thornborough Events activities. The granting of a licence which could see similar music / entertainment twice weekly until 11pm, on Sunday until 10pm, for up to 52 weeks of the year would be extremely (and literally) disturbing.

I am writing to object to the granting of permission to operate a licensed entertainment business on agricultural land at Thornborough Farm. They have already run events and the noise generated was intolerable and was so loud that picture frames moved on the walls. This is not acceptable in a peaceful rural environment. I value the peace and quiet and cannot conceive that anyone would imagine it suitable to destroy the peace and quiet by operating such events, especially on a regular basis that would give us no reprieve.

If the license were to be granted, we would need to move away as soon as possible, but it is quite likely that no-one would want to move into such an environment so the value of our home would be substantially reduced making it impossible to move.

As well as the unacceptable noise, I would have concerns about security and traffic with strangers to the area taking wrong turns and ending up blocking the narrow lanes in this area with potential road rage spilling over into local properties and impacting local drivers.

There is an undoubted lack of public transport and with alcohol on sale to people who have arrived in their own vehicles the risk of accidents, perhaps involving local residents, could be significant.

Please do not grant permission for any such events to take place in the agricultural field that is so close to where I had hoped to quietly enjoy my retirement.

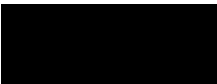

I live at [REDACTED] which is very close the proposed event location, just a couple of fields away.

My objections relate to the licensing objectives below:

1. prevention of public nuisance - The site is already causing a public nuisance by way of excessive noise from live music, playing of recorded music and the DJ/public announcements associated with them. We have made numerous complaints about existing events which spoil the enjoyment of out property. Noise from the events is very load at out home. You can often feel the base and hear every lyric of the music. The music can be so loud that it can even be heard in doors. They do not appear to have made any provision for remote monitoring of sound or any consideration for neighbouring properties. Please do not increase the distress that this causes us by increasing the number of events.
2. the prevention of crime & disorder - We raise concerns about the potential for an increase in crime and disorder often associated with alcohol and excessive drinking. We are writing with regards to the proposed Premises Licence application in relation to the site at Thornborough Farm.

This is, by definition, an agricultural site with land designated for agricultural purposes and yet it is seemingly being used now for entertainment use, in contravention of the applicable planning laws.

We live in one of a number of properties close to the site and at various times last year, and this, have had our evenings and nights blighted by the noise coming from various events on the site. So much so that it is impossible to sleep with windows open, or shut, well into the night.

On one occasion last year, the live "music" finished at 11pm, to then be superseded by a "disco" which was even louder and which went on until 1pm.

We live in a rural area and do not expect to have our peace and quiet continuously disturbed in this way. It is possible, even during the afternoons when these events are in progress, to still hear loud music well over a mile away from the site.

There are plenty of music and event venues within the Midlands area, in purpose built or far more suitable locations, without the need to bring havoc and disturbance to a rural location.

These events do not in any way benefit the local community. There are no shops or significant hospitality venues to benefit from an influx of people.

This is purely a cynical attempt to misuse farmland to make a quick profit, and given the location of the site, and many other far more suitable locations in the general area, an attempt which will ultimately fail as a business, doing nothing other than upsetting a great number of local residents in the meantime.

This is no case of "Nimby-ism" either. I attended a great many very loud music festivals in the past, including the first 5 Monsters of Rock festivals at Castle Donnington. However, these were held far away from residential sites, in suitable and appropriate locations.

A number of our neighbours are elderly, or unwell, and they in particular do not need the stress and disturbance that these events bring. People chose to move to, and live in, rural areas for the peace and quiet, not to live next to some half arsed version of Glastonbury.

We were somewhat dismayed to hear that the local Council and Police thought that this is a suitable location for these types of events, which shows a complete lack of appreciation for the local community. Maybe an alternative location for these events could be found near to the homes of the Council members/Police who approved the initial application, so that they can enjoy the noise, traffic and general disturbance?

If these events are allowed to continue and increase, then these activities will be highlighted also on any property searches conducted by solicitors as and when residents wish to sell their properties. Presumably then we will be able to claim against the Council for any reduction in the market value of our properties as a direct result of a decision to grant a Licence.

We hope that common sense, together with a respect of the right of the ability to have peaceful enjoyment of one's own property, will prevail.

I was dismayed when, contrary to all the searches conducted during conveyancing, it came to be that Thornborough Farm began running events at weekends that created precisely what I thought I had escaped from, with incessant noise pollution during weekend events, accompanied by light pollution and also a very noticeable change in the local environment, such as considerable litter strewn around the private roads between Lea End Lane and Forhill Court.

My family and neighbours live in a quiet rural setting, some living there for Over 60 years. And only since this field has been used has there been so much interference of a peaceful way of life.

Some people there are elderly and rightly so are very concerned about security and safety especially those living alone. As alcohol on tap from 1200 till 2300 will mean some may well cause trouble for the locals as well as people driving under the influence could cause accidents.

Also there would be considerably more traffic using the country lanes as well as Redhill road which is already a very fast road.

The applicants have been arranging events on the grounds for a number of years with no regard to the local residents , there was an event last year and the music was so loud that we recorded a sound level of above 50 DBA at our rear bedroom windows , we contacted Trornborough events and were told that the only constraint they needed to meet was 87 DB at the stage , the event continued over the weekend with the music only stopping at 1.30 am on the Sunday morning.

This issue was also reported to Bromsgrove Council who had had a number of complaints but to our knowledge no further action was taken as it was arranged under an emergency permit .

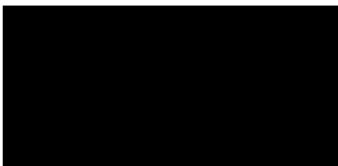
The field that the events are held on is supposed to be green belt in a conversation area and yet Trornborough events are holding at least 20 car boot sales on Sundays together with all the events both planned and future events advertised which exceeds the 28 days indicated on the application .

We found a rejected planning permission to start a small equestrian school adjacent to the events field rejected but then it was submitted under another name and the school has not yet received planning however the school is in operation , this does not fill us with any confidence that the restrictions will be followed as the application states .

We are also concerned with the traffic issues which was one of the reasons the school was refused planning yet the application seems to suggest the could be up to 200 people attending events which due to the non existence of any local transport there would be around 100 cars at best arriving and leaving the site . The site entrance has no formed entrance with the gate just set back from the road with no area for cars to drive off the road before entering the site (this is an issue each time there is a boot sate as the cash for parking / pitches is taken at the gate to the site with no personnel from the event controlling the traffic at the end of the sale)

As you can see as a local resident, we are extremely concerned about the direct effects on us plus the ever expanding use of a agricultural field without any proper planning permissions that any other change of use would be subject to .

I am writing to object to the application by Thornborough Farm to operate an entertainment venue in an agricultural field.

We have already endured these events on multiple occasions and they have caused noise disturbance for local residents, which should not happen in a rural, green belt area. The location is unsuitable for use by large numbers of people. The road is a small country lane and is the main access road for everybody living in the area. Several hundred vehicles descending on the area will cause disruption to people going about their daily lives, as the entrance and exit will be unable to accommodate this much traffic. This will cause queues and accidents will be more likely as drivers will not be expecting the road to be so busy.

The unlimited sale of alcohol every weekend during the summer will increase noise pollution, especially when the sale will continue after the extreme noise from live and recorded music ends. In addition, there is a lack of emergency provision in the area, with the nearest hospitals being some distance away, and this could cause any incidents to have more serious consequences. This could also impact our security as any disturbance or violence from people who have consumed large quantities of alcohol is not guaranteed to be contained to the site, but likely to spread to the local area. It is not possible for law enforcement to reach the site quickly if needed, due to the distance from any police resources.

I am also concerned about the increase in litter which seems to accompany festivals. It seems to be accepted that people will leave anything and everything behind when they leave these sites and this is unlikely to be contained on the site itself. This would constitute a nuisance for area residents and local livestock alike.

I think the area is not likely to enhance the local area. It would decrease property values considerably as it would constitute a public nuisance rather than an attraction.



I want to be completely transparent from the outset: I am a close friend of **Ken Moore**, the owner of the Thornborough events field. However, this closeness does not influence my perspective—as one of the nearest neighbours to the site, I'd be just as concerned about noise or disruption as anyone else. If my support is discounted because of this friendship, then the same reasoning should fairly be applied to objectors living further away.

It is also worth noting that Ken is applying for a **Premises Licence**, rather than continuing to rely on repeated **Temporary Event Notices (TENs)**. While a TEN may suit very occasional, small-scale events, it comes with strict limits on capacity, duration, and number of uses per year. A Premises Licence, on the other hand, provides a single, comprehensive framework that sets out clear conditions for noise control, safety, and community protection. This approach ensures accountability, consistency, and long-term clarity—making it the more responsible option for a site hosting regular, well-managed events.

I have never had cause to raise concerns with Ken about these events—for good reason, they are well-run and respectful of the local community. I would not tolerate excessive noise, antisocial behaviour, or litter, and I know Ken would not expect his neighbours to either. In fact, music has always finished on time, and the site has been well kept afterwards.

My wife and I enjoy attending these events ourselves. They give us the chance to meet others from the community, and we always return home without late-night disturbance. On occasion, we've even helped neighbours along Bell Green Lane find their way home after a fun evening—an example of the friendly and supportive atmosphere these gatherings create.

In a time when living costs are high and ticket prices at larger venues are becoming unaffordable, the Thornborough events field offers something invaluable: affordable, local entertainment that allows people to try something new. Personally, I never expected to attend reggae or country and western concerts, yet I did—and I thoroughly enjoyed them. It was also wonderful to see how far people had travelled to experience something special in this setting, so close to Birmingham.

I also had the pleasure of chatting with a wood-fired pizza vendor at one event this year, simply picking up some home cooking tips—a small but meaningful takeaway.

As a local business owner and member of the Entrepreneurs Circle, I cannot emphasise enough how important it is to support this kind of diversification. These events are culturally enriching, socially beneficial, and provide genuine economic value to the local area.
