1/07 ELECTION OF CHAIRMAN

<u>RESOLVED</u> that Councillor Dr. G. H. Lord be elected Chairman of the Committee for the remainder of the municipal year.

2/07 ELECTION OF VICE-CHAIRMAN

<u>RESOLVED</u> that Councillor R. J. Deeming be elected Vice-Chairman of the Committee for the remainder of the municipal year.

3/07 APOLOGIES FOR ABSENCE

An apology for absence was received from Councillor R. J. Deeming.

4/07 DECLARATIONS OF INTEREST

Councillor R. D. Smith declared a personal interest in respect of the item relating to the Polling District Review (Minute No. 6/07) stating that, as Catshill Village Hall was used as a polling station, he was a Trustee of the Catshill Village Hall Management Committee.

5/07 <u>MINUTES</u>

The Minutes of the meeting of the Committee held on 16th March 2006 were submitted.

RESOLVED that, subject to the amendment of the date of the meeting from "16th March 2005" to "16th March 2006", the Minutes be approved as a correct record.

6/07 **POLLING DISTRICT REVIEW**

Mrs. C. Cockell, Acting Electoral Services Manager, presented the report which outlined a review of Polling Districts and Polling Places within the District, in accordance with the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006. Consideration was then given to the report and the following matters were raised by Members:-

- Councillor C. J. Tidmarsh asked whether the review was limited to the Bromsgrove District area, or whether it included the polling arrangements between neighbouring districts. In reply, Mrs. Cockell stated that the review related solely to the Bromsgrove District, and stated that boundaries between authority areas were a matter for the Boundary Commission for England.
- Councillor D. McGrath suggested that the Hawthorns Social Club, 59 Rednal Hill Lane, Rubery, be considered as a possible additional polling station. Mrs. Cockell agreed to investigate this issue.
- Councillor Mrs. J. M. L. A. Griffiths referred to the polling station at the Brooklyn Citroën Garage, Birmingham Road, Bordesley, and stated that she would not wish for the polling station to move to the Travel Lodge, as stated in the report. Mr. Dicks and Mrs. Cockell stated that future polling arrangements at Brooklyn Citroën Garage would be investigated.
- Councillor W. R. Newnes raised a question over the future use of the Meadows First School Hall which was currently being reconstructed, in conjunction with Parkside Middle School. Mrs. Cockell stated that this would be reviewed when the new school had fully replaced the previous building.
- Councillor Newnes also referred to the use of school premises in general and the general (unwritten) policy of minimising disruption to school premises. The Chairman stated that, in some situations, this was unavoidable, especially in terms of the costs of hiring rooms for polling station purposes.
- Councillor L. J. Turner commented on the findings in the report in respect of Wake Green AFC Pavilion, stating that an alternative location may be difficult to locate. Mrs. Cockell stated that no, or few, complaints had been received in respect of the use of the pavilion as a polling station and added that further discussions with Wake Green AFC would be undertaken.
- The Chairman referred to the Rowney Green Peace Memorial Hall, Rowney Green Lane, Alvechurch, where a lottery funding application for improved disabled persons access had been submitted. As a result, any concerns over access to the polling station would be overcome in due course.
- In addition, the Chairman raised a question relating to the use of the Cricket Pavilion at Romsley and Hunnington Cricket Club, Bromsgrove Road, Romsley, but Mrs. Cockell stated that there were no suitable alternative locations.
- The Chairman also suggested that an additional polling station in Catshill would be of benefit in respect of access for voters on the Stourbridge Road side of Catshill. Mrs. Cockell assured Members that this issue would be looked into.

 Councillor S. P. Shannon referred to the SCOPE report over the use of Aston Fields Social Club, Stoke Road, and agreed with its findings in respect of the possible use of the Salvation Army Hall in Carlyle Road. He also suggested the Finstall Centre, Stoke Road, as a further possible alternative. Mrs. Cockell stated that these would be investigated.

<u>RESOLVED</u> that (i) with the exception of the recommendations relating to the Brooklyn Citroën Garage, Birmingham Road, Bordesley; and (ii) subject to the comments and suggestions raised by Members outlined above, the report be accepted.

7/07 ABOLITION OF LICKEY END PARISH COUNCIL

Members considered a report relating to a request from Lickey End Parish Council to return the area to its previously unparished state.

<u>RESOLVED</u>

- that, under the Local Government and Public Involvement in Health Act 2007, the Council seek to abolish Lickey End Parish Council without reference to the Secretary of State for Communities and Local Government;
- (ii) that, in the event of the Council being unable to abolish Lickey End Parish Council without reference to the Secretary of State for Communities and Local Government as referred to in (i) above, the Chief Executive write to the Department for Communities and Local Government seeking the abolition of Lickey End Parish Council; or
- (iii) that, should the Secretary of State for Communities and Local Government consider that a review is required, the Chief Executive be authorised to undertake a consultation exercise within the Lickey End Parish Council area as to the proposed abolition of Lickey End Parish Council, and to report the findings of the review to a future meeting of the Committee.

ANNUAL POLLING STATION REVIEW

1. SUMMARY

1.1 To undertake an annual review of all Polling Districts and Polling Places within the District of Bromsgrove in compliance with The Review of Polling Districts & Polling Places (Parliamentary Elections) Regulations 2006.

2. **RECOMMENDATION**

2.1 That the review of polling districts and places shown at Appendix 1 be approved and adopted.

3. BACKGROUND

- 3.1 The Electoral Administration Act 2006 requires all local authorities in England and Wales to undertake a full review of Polling Districts and Polling Places every 4 years. An annual review of polling places is considered good practice.
- 3.2 In undertaking the review, the Council must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances, and have regard to the needs of electors who are disabled.
- 3.3 This review is not concerned with alterations to Ward boundaries, only Polling Districts and the situation of polling stations.
- 3.4 Consultation has been sought from District Council Members, Parish Councillors and Parish Clerks.

4. **FINDINGS**

4.1 All polling places and polling stations within the District have been evaluated in terms of suitability and accessibility. The law says that facilities for voting must be reasonable and practicable. What this means in practice is a matter of

judgement, but there is certainly no duty on the Council to make an unreasonably high level of provision, or to provide facilities in locations where it is impracticable to do so.

4.2 <u>Representations Received</u>

Councillor Mrs. C. J. Spencer has commented that the size and style of the portable building unit used at the by-election held in Slideslow Ward earlier this year needed to be reviewed.

5. **REVISIONS RECOMMENDED**

- 5.1 Whitford Polling District (VA) more suitable premises for use as a polling station have been identified to replace the Sanders Park Pavilion for this polling district. The Girl Guide Building, Kidderminster Road, has recently been upgraded to meet the Disabilities Act recommendations, with a suitable ramped access and double door leading to a large hall; it also has full kitchen and toilet facilities for staff with ample car parking and a public footpath leading to the location.
- 5.2 To respond to Councillor Mrs. Spencer's comments, portable building units are only used as a last resort when permanent buildings are unavailable in an area. However, specifications for these have been revised to larger units with two doors wherever possible enabling an entrance and an exit facility and new suppliers are being sought for future elections. Other improvements that are being looked at are the provision of a more permanent supply of electricity for the portable units to reduce the need for the hire of noisy portable generators.

6. FINANCIAL IMPLICATIONS

6.1 There are cost implications for the provision of larger portable units and the possible permanent supply of electricity for up to three sites using portable building units; these should be included within the medium term financial plan.

7. LEGAL IMPLICATIONS

7.1. In accordance with the requirements of section 18C of the Representation of the People Act 1983.

8. COUNCIL OBJECTIVES

8.1. Helping to meet the needs of our customers by eliminating discrimination and promoting equality.

9. RISK MANAGEMENT

9.1 There are no significant risks associated with the details included in this report.

10. CUSTOMER IMPLICATIONS

10.1 Changes of polling stations will be identified to the elector by a special note included on their polling card.

11. EQUALITIES AND DIVERSITY IMPLICATIONS

11.1 By addressing the issues with regard to access to the Polling Stations the Council is improving access to all areas of the Community.

1. SUMMARY

1.1 To report a revision of codes used to represent the polling districts in the Register of Electors.

2. **RECOMMENDATION**

2.1 That the list of polling district codes attached at Appendix 1 be approved.

3.1 Polling district codes have previously been a purely alphabetical list. The new list of codes represents the wards using the first two digits and the particular polling district with the third digit which will make it easier to identify.

6.1 The revision of the polling district codes should aid a sense of community by achieving a much more logical system of identification of the wards and their associated polling districts.
