19/08 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Mrs. M. A. Sherrey, Mrs. C. J. Spencer and D. McGrath.

20/08 **DECLARATIONS OF INTEREST**

No declarations of interest were received.

21/08 **MINUTES**

The minutes of the meeting of the Licensing Committee held on 21st July 2008 were submitted.

RESOLVED that the minutes be approved as a correct record.

22/08 DESIGNATED PUBLIC PLACES ORDER - COFTON HACKETT

Consideration was given to introducing a Designated Public Places Order (DPPO), which would prevent, when requested, the consumption of alcohol in the Cofton Hackett area in an attempt to reduce anti-social behaviour and drinking in these public areas. This matter was being brought before the Committee as the Police, who are responsible for enforcing any restrictions on public drinking in designated areas, were not willing to support this particular request as they had insufficient evidence of anti-social behaviour caused by alcohol consumption in the area, and felt that they already had sufficient measures in place to keep any anti-social behaviour occurring in the area under control.

At the Chairman's discretion, Councillor P. M. McDonald, County Councillor representing the County Electoral Division for Beacon, spoke in favour of introducing a DPPO in this area. In doing so he stated that it had been raised as a top issue during a PACT (Partners and Communities Together) meeting and during an additional Public Meeting. In addition over four hundred people had been contacted and Neighbourhood Watch had expressed concern

regarding the consumption of alcohol. A Dispersal Order under Section 30 of the Anti-Social Behaviour Act 2003 had been implemented by an adjoining authority.

It was noted that information provided by the police had shown that during the period from 1st June 2007 to 27th November 2008 only 4 incidents out of a total of 59 reports of anti-social behaviour were linked to the consumption of alcohol in the area. Following discussion on the absence of clear evidence of alcohol related public nuisance or disorder, it was

RESOLVED that the request for the creation of a Designated Public Places Order in the Cofton Hackett area, Bromsgrove be deferred until the next Licensing Committee meeting. Officers were tasked to obtain further evidenced information from Neighbourhood Watch, West Mercia Constabulary and PACT meetings.

23/08 TAXI LICENSING HANDBOOK

Consideration was given to a report seeking approval to adopt the revised policy and licence conditions in respect of all taxi licensing matters, to be incorporated into the Council's Taxi Handbook. Members were made aware that Bromsgrove District Council had worked with other licensing authorities across Herefordshire and Worcestershire in an attempt to bring together guidance, licence conditions and policies relating to all aspects of taxi licensing, into one handbook, to be used throughout the County. Following a period of consultation and discussions with County colleagues, it had become apparent that this was not feasible, at this present time, due to the reasons highlighted in the report.

RESOLVED:

- (a) that the policy elements and licence conditions relating to taxi licensing, as set out in the Taxi Handbook be approved for adoption; and
- (b) that the proposed transition periods for the policy changes to take effect be approved.

24/08 GUIDANCE RELATING TO THE RELEVANCE OF CONVICTIONS AND CAUTIONS

The Committee considered a report on a proposal to adopt a revision of existing guidance to Licensing Committee Members and applicants on the relevance of convictions when granting either a Dual Hackney Carriage and Private Hire Driver's Licence or Private Hire Operator's Licence.

RESOLVED that the revised guidance on the relevance of convictions and cautions be approved for adoption.

25/08 **HACKNEY CARRIAGE STANDS**

The Committee gave consideration to a report which outlined proposals to create two new Hackney Carriage Stands, and on the proposed reconfirmation of two existing Stands. Following a review of all Hackney

Carriage Stands in the district, the Council had been approached by the Police Authority to look at introducing an additional Hackney Carriage Stand in the Town area to help reduce crime and disorder during the evenings, as well as enhancing current taxi rank provision.

RESOLVED:

- (a) that the creation of a new Hackney Carriage Stand at Worcester Road, Bromsgrove, as set out in the report, be approved;
- (b) that the creation of a new Hackney Carriage Stand at New Road Service Road, Rubery, as set out in the report, be approved;
- (c) that the re-confirmation of an existing Stand at The Strand, Bromsgrove, as set out in the report, be approved; and
- (d) that the re-confirmation of an existing Stand at Market Street Bus Station, Bromsgrove, as set out in the report, be approved; with all Stands being subject to the necessary amendments being made to Traffic Regulation Orders.

26/08 LICENSING SUB-COMMITTEE SITE VISITS

Consideration was given to a report on the current process relating to site visits and whether to recommend to Council that the Licensing Code of Practice be revised. Members had queried the possibility of Licensing Sub-Committees undertaking site visits in cases where it would be helpful in the determination of applications. Following discussion it was

RESOLVED that authority be delegated to the Senior Solicitor in consultation with the Chairman and Vice-Chairman to prepare a revised draft Licensing Code of Practice.

RECOMMENDED that the Council adopt the revised Licensing Code of Practice, which forms part of the Constitution.

27/08 <u>LICENSING SUB-COMMITTEE REVISED HEARING PROCEDURES</u>

The Committee gave consideration to a report which outlined the periodic reviews of Committee Hearing Procedures. The Licensing Sub-Committee Hearing Procedures had recently been reviewed in order to shorten the time allowed for representations to be made, to simplify the language and to clarify certain aspects of the procedure. Officers informed Members that hearing procedures would be regularly reviewed. Following discussion officers were tasked to draft a brief guide providing information for Public Speaking at Licensing Sub-Committees.

RESOLVED that the Licensing Sub-Committee Hearing Procedures be revised, as set out in Appendix 1 of the report.

1. SUMMARY

1.1 To consider introducing a Designated Public Places Order in the Cofton Hackett area.

2. **RECOMMENDATION**

- 2.1 That Members either:
 - approve the creation of a Designated Public Places Order as outlined on the attached plan; or
 - refuse the request.

3. BACKGROUND

- 3.1 Members may recall at the previous Licensing Committee Meeting, the Council had been approached by the County Councillor representing the County Electoral Division for Beacon to look at introducing a Designated Public Places Order to prevent, when requested, the consumption of alcohol in the Cofton Hackett area in an attempt to reduce anti social behaviour and drinking in these public areas. Details of the request is attached at Appendix 'A'.
- 3.2 The Criminal Justice Police Act 2001 allows local authorities to designate areas for this purpose only where they are satisfied that nuisance or annoyance to the public or disorder has been associated with drinking in a public place. Each DPPO must be considered on its own merits, based on any evidence gathered.
- 3.3 These powers are not intended to disrupt peaceful activities, for example families having a picnic in a park with a glass of wine. Police Officers can use their discretion when deciding to request an individual to refrain from drinking regardless of their behaviour. Home Office guidance suggests that it is not appropriate to challenge an individual consuming alcohol where that individual is not causing a problem.

- 3.4 The Regulations governing the creation of such an Order do not place a requirement on the local authority to conduct a formal assessment of the area in question, over a given period, of the nature of the problem. However the local authority will want to satisfy itself that the powers are not being used disproportionately or in an arbitrary fashion in the case of say, one isolated incident. Consequently there should be clear evidence of an existing problem, with an assessment as to the likelihood that the problem will continue unless these powers are adopted and the belief that the problem could be remedied by the introduction of such an Order. The Council would look to the Police to provide this evidence.
- 3.5 In December 2008 the Home Office published Guidance relating to Designated Public Place Orders (DPPOs): For Local Authorities in England and Wales. This sets out guidance for local authorities on the issue of evidence required to justify making a DPPO as follows:

"The evidence you will require for a DPPO is that there is an alcohol related nuisance or annoyance to the public in the proposed area/s. You should make an assessment as to the likelihood that the problem will continue unless these powers are adopted. In addition, you must have a belief that the problem could be remedied by the use of these powers. Evidence should be based not just on information you have obtained, but also from the police and members of the local community who have reported incidents of alcohol-related anti-social behavior or disorder. Evidence of alcohol-related nuisance could for example include litter related to the consumption of alcohol (e.g. bottles and cans) as well as police information and residents' complaints."

- 3.6 In order to gain this necessary evidence, the Regulations require local authorities to consult with the Police Authority to seek their views on the nature of the problem and the appropriateness of introducing such an Order, as well as recognising that it will be the Police who will have the responsibility for enforcing the restrictions on public drinking in the designated area.
- 3.7 On this occasion, the Police, at present, are not willing to give their support to this particular request for a Designated Public Places Order, as they have insufficient evidence of anti social behaviour caused by alcohol consumption in this area. They feel that they already have sufficient measures in place to keep any anti social behaviour occurring in this area, under control. A copy of their response is attached at Appendix 'B'. The Police have been invited to attend this meeting at the request of the Licensing Committee.
- 3.8 During the period from 1st June 2007 and 27th November 2008 only 4 incidents out of a total of 59 reports of anti social behaviour were linked to the consumption of alcohol in the area.
- 3.9 Members may recall at the previous meeting, it was agreed that minutes from recent Neighbourhood Watch meetings and PACT meetings for the

Cofton Hackett area be provided to Members. Copies of the minutes from recent Neighbourhood Watch Meetings are attached at Appendix 'C'. Members will note from these minutes, the issue of a DPPO was raised on a number of occasions during the last 12 months, the following is an extract taken from each set of Neighbourhood Watch minutes:

- 3rd March 2009 "Alcohol Free Zone for Cofton Hackett ("AFZ") PACT has taken it forward to the licensing committee they depend upon "figures of disorder" i.e., reported incidents to the police / Council. Only 9 people attended Cllr McDonalds meeting of which 7 voted for an AFZ. A decision has been deferred as the police want to investigate what is happening in Cofton Park and West Midlands police area; Sgt Wilkes also requested assistance from CHNW and PACT in gathering a more comprehensive view of local opinion as Cllr McDonalds meeting unfortunately clashed with others. Sgt Wilkes wishes to hear from anyone with incidents, either current or historical, so that he can present true opinion. Please email: mark.wilkes@westmercia.pnn.police.uk see attached leaflet at the end of the minutes."
- 7th October 2008 "A meeting has been arranged by Councilor Peter McDonald to discuss Cofton Hackett becoming an Alcohol Free Zone. Cofton Village Hall, 16th October at 7pm. CHNW encourages all residents to attend and await the outcome with interest. NW have made some enquiries from a local police perspective, who are supportive of an alcohol free zone, however, the District Council and licensing committee utilise Police Crime report statistics and the level of alcohol fuelled disorder, according to the a, may not provide enough justification at this time for an alcohol free zone to be adopted within Cofton Hacket. The meeting therefore encourages all residents to report alcohol related incidents (including ASB., litter etc). Issues raised at tonights meeting included Cofton Park being included in such a scheme. Please raise at Cllr Mc Donalds Meeting."
- 4th September 2008 "Two applications for play areas to become "Alcohol Free Zones" have been denied in Bromsgrove. This decision was made due to insufficient evidence, as only three incidents have been reported for the two areas in the past two years. As this has been a raised issue at Cofton Hackett PACT, Emily stressed the significance and importance of reporting all incidents to the police. Drink related incidents and antisocial behaviour are being tackled in Bromsgrove by the local Police Tasking Team (LPTT) by serving Section 27 notices. This can be used on anyone aged 17 or above and requires them to leave a specified area for up to 48hours(The Standard Aug 22nd)"
- 5th February 2008 "Alcohol Free Zones: A member asked why this scheme, presently in use in Rubery and Alvechurch, could not be adopted in Cofton Park? The meeting was advised to bring up this issue at the next PACT particularly if attended by West Midlands Constabulary police."

- 3.10 The proposal to introduce a DPPO was discussed at the PACT meetings held on 24th April 2008, 17th July 2008, 16th October 2008 and 15th January 2009 and it was agreed to take it forward as a priority. Attached at Appendix 'D' is a resume of the PACT meetings.
- 3.11 The Regulations also require local authorities to consult with the following interested parties:
 - The Parish or community Council covering all or part of the public place to be designated;
 - The neighbouring police and local authority in cases where a designation order covers an area on the boundaries with that neighbouring authority:
 - Any premises licence holder, club premises certificate holder or premises user;
 - Reasonable steps should also be taken to consult the owners or occupiers of the land proposed to be designated.
- 3.12 A public notice was placed in the Bromsgrove Standard on 10th April 2009 inviting comments on the proposed order. A response has been received from a local resident and a copy is attached at Appendix 'E' for members information. The resident feels that it is not necessary to include Oakfield Drive in the proposal.
- 3.13 A verbal response has been received from the Premises licence Holder who operates the a premises on Parsonage Drive, who also feels that he has not encountered any anti social behaviour as a result of people drinking alcohol in the vicinity of his premises, he further stated that he has not had to deal with under age people trying to purchase alcohol from his premises.
- 3.14 A response has been received from Birmingham City Council who offer no objection to the proposals. In compiling their response they had consulted with West Midlands Police. A copy of their response is attached at Appendix 'F'.
- 3.15 At the time of writing this report no response has been received from Cofton Hackett Parish Council.
- 3.16 A plan showing the location of the proposed Order is attached at Appendix 'G'.
- 3.17 Should Members decide to approve the proposed Order, it will be necessary to place another public notice in the local press, informing the public of the consequences of the Order, as well as arranging for signage to be erected in the area.
- 3.18 Finally, for information purposes, Members may wish to note that Appendix 'H' set out those areas in the District where DPPO's have already been granted, following the support of the Police. To date no DPPO has been granted without the support of the Police.

4. FINANCIAL IMPLICATIONS

- 4.1 The cost of the public notice and other administrative costs will be met from existing budgets held by Planning and Environment Services.
- 4.2 There is no budget available for signage informing the public that an area(s) area is within a Designated Public Places Order. However, if Members agree to introduce the Order in Cofton Hacket, an approach will be made to the Crime and Disorder Reduction Partnership to fund this scheme in conjunction with the Council's Community Safety Team.

5. LEGAL IMPLICATIONS

- 5.1 Licensing Authorities have power under Section 13 of Criminal Justice and Police Act 2001 to introduce and revoke Designated Public Places Orders in association The Local Authorities (Alcohol Consumption in Designated Public Places) Regulations 2007.
- 5.2 There is a requirement under the Criminal Justice and Police Act 2001 Section 13 (2) that:
 - "A local authority may for the purposes of subsection (1) by order identify any public place in their area if they are satisfied that-
 - (a) Nuisance or annoyance to members of the public or a section of the public; or
 - (b) Disorder;

has been associated with the consumption of intoxicating liquor in that place."

5.3 With reference to Paragraph 4 of the Regulations, it specifies that when a Local Authority is deciding an application for a Designated Public Places Order, it shall consider any representations as to whether or not a particular public place should be identified in an Order.

6. COUNCIL OBJECTIVES

6.1 This proposal contributes to the Council's objective "Sense of community and well being".

7. RISK MANAGEMENT

- 7.1 The main risk associated with the detail included in this report are:
 - Introduction of a Designated Public Places Order without the support of the Police Authority

8. CUSTOMER IMPLICATIONS

8.1 All relevant parties will be notified in writing within 5 working days of the Council's decision.

8.2 If Member's decide to adopt this scheme, there is a risk that members of the public may complain to the Council that the Police are not enforcing the terms of the Order, as expected.

9.1 There are no equalities and diversity implications.

10. VALUE FOR MONEY IMPLICATIONS

10.1 If Members are minded to approve the introduction of the Order, it could be conceived that the Council is not providing value for money as the Police are not in support of the proposal and may not be in a position to enforce the restrictions imposed by the Order. The Police already have alternative powers to deal with anti social behaviour.

Please see the attached report from Bromsgrove's CDRP Analyst, Emily Humphreys. The Analyst's report is derived from data collated from the Police CRIMES database between 1 June 2007 and 27 November 2008 (18 months).

In summary, during this period, only 4 incidents out of a total of 59 reports of Anti Social Behaviour in the proposed Alcohol Free Zone, were flagged up as Having been alcohol related.

In addition, Rubery Local Policing Sergeant, PS Mark WILKES, having reviewed this data, sees little value in pursuing the application any further. (Copy also attached)

Based on this evidence, we (the Police), under the Alcohol Consumption in Designated Public Places Regulations 2007, cannot be 'satisfied that nuisance or annoyance to the public or disorder has been associated with drinking in the aforementioned place', and therefore cannot support this application

Alcohol-related Disorder in Cofton Hackett – Alcohol Free Zone Proposal

An application has been made for an Alcohol Free Zone (AFZ) in Cofton Hackett. The following report outlines the number and type of anti-social behaviour incidents occurring within the proposed AFZ area (as defined those incidents where the easting and northing given in the incident/offence record places them within the boundary on the below map). All data is collected from the Police CRIMES database. All data collected from the period 01 June 2006 and 27 November 2008 (18 months).




FIGURE 1: LOCATION OF THE PROPOSED AFZ

Alcohol-related Disorder in Cofton Hackett 01/12/2008

General ASB Incidents in the AFZ Area - summary of relevant points

- Of a total 38 rowdy behaviour complaints in the area, 31 related to youths, and 26 specifically to youths gathering on the streets.
- More youth related ASB took place on Oakfield Drive than any of the other roads in the AFZ area, with 10 incidents logged there over the last 18 months. Chestnut Drive was the location for 8 incidents, several of which took place in the play area there. 6 Incidents were logged on Parsonage Drive (not including those at the Focus store). The allotments behind Oakfield Drive, and the Myhill fields and play area were also repeat locations, especially for vandalism and graffiti related complaints.
- The Focus store on Parsonage Drive was a specific hotspot location for youth related anti-social behaviour. Complaints included youths gathering on the car park and in the loading area, running in between moving cars and forklift trucks at considerable risk to their own safety, messing around with the trollies and playing football. Of the total 8 incidents reported at Focus in the last 18 months, all but one took place since April 2008, with 3 in July 08 and 3 in September 08, suggesting that this behaviour is increasing in frequency.
- The number of incidents in the AFZ area seems to be following a decreasing pattern with only 8 incidents since June 2008, compared to 13 between June and November 2007.

Alcohol-related Incidents

- Only 4 of the 59 total ASB incidents in the area during the last 18 months were flagged up as being alcohol related, where alcohol consumption was mentioned in the log text of the report.
- 3 of these alcohol related incidents were linked to youths gathering, outside
 the shops on Groveley Lane/Parsonage Lane, in the park opposite Ashmead
 Drive, and in a bus stop on Groveley Lane. The other incident related to an
 intoxicated customer inside the Focus store and is therefore not relevant to
 an alcohol free zone application.
- Aside from the consumption of alcohol by youths in a public place, the other aggravating factors prompting these ASB complaints included the youths being loud, and climbing on the bus stop.
- In one report logged in March 2008, it was mentioned that gatherings of this nature were an ongoing issue.
- All 3 incidents had been logged between 22nd February and 4th April 2008.




FIGURE 3: NO. OF TOTAL ASB AND YOUTH-RELATED INCIDENTS PER MONTH IN PROPOSED AFZ (01 JUNE 2006 TO 27 NOVEMBER 2008)

- In general, there have been an average of 3 anti-social behaviour incidents per month over the last 18 months within the proposed AFZ area, and an average of 2 youth related incidents per month.
- The total of 4 alcohol related ASB incidents reported in the space of 18 months does not indicate a significant problem with alcohol/street drinking. However, the 3 incidents that were relevant to an AFZ application all took place between 22nd February and 4th April 2008, a period of just over 6 weeks, with none occurring before or after those dates, suggesting alcohol-related ASB may have been a significant issue in the area during that time.
- There does seem to be an ongoing issue with youths gathering in the area, but seldom is alcohol mentioned in the complaints relating to this – indicating that an alcohol free zone may not be effective in reducing this type of behaviour.

It is important to note that alcohol-related incidents are identified as those mentioning one or more of the following key words in the logs text of the incident report:

Drink, drunk, alcohol, intoxicated, public house, licensed premise, wine, beer, vodka, lager, spirit.

This method, though the most effective way of definition available at present, does lead to a certain amount of inaccuracy. If a word is misspelled, or alcohol is not mentioned specifically in the text of a report, then incidents will not be identified and included in analysis.

On informing the police and asking if any recent incident in Cofton could be connected with this find, she was told they would ring her back. Eventually the police in Kidderminster did make contact & told her to dispose of the items. The residents felt the police staff had been dismissive and felt that this find was significant. - Today A press release has been received, stating a Digital Camera has been found (possibly stolen in a local burglary) in Rubery, containing sentimental photos of a family. They are trying to Identify its owners.

4 Police Update. Provided by Sgt Mark Wilkes:

Due to the recent spike in burglaries in Cofton Hackett and Barnt Green, Operation Cofton II has been launched. This entails: - an increase in visible police patrols and Community Support Officers in the area as well as the distribution of Crime prevention Leaflets;

- The Use of Smartwater is encouraged and liaison with West Midlands Police in identifying offenders who may be from across the border;
- ANPR (Automatic Number Plate Technology) enables police to identify vehicles of known offenders.

Sgt Wilkes informed the meeting that a significant arrest has been made and that there have been no further incidents in Cofton Hackett since Oct 14th. Police are now trying to identify and reunite stolen property with their rightful owners. This is not always easy unless the property is marked (e.g. Smartwater).

Our local Police team are working hard to enforce legislation under The Proceeds of Crime Act whereby police can seize assets from those who make their living through crime. This was welcomed by the meeting.

We have a new police telephone number (as from 2nd November)

West Mercia Police Number is now 0300 3333000.

This is a reduced rate telephone number and replaces the former, more expensive, 08457 444888 number, although there is a few months "crossover period".

There continues to be thefts from cars parked in local beauty spots. Once again the police are asking people not to leave valuables either on show or in their boots. If people are victims of crime, they would like to be informed immediately so that forensic evidence can be collected at the scene of crime.

Sgt Wilkes was informed of a residents concern regarding anti social behaviour in Parsonage Drive, whereby some local residents are fearful of retribution if they report incidents to the police. Sgt Wilkes and the subcommittee urge anyone to report any anti social behaviour. Sgt Wilkes recommended the crimestoppers number

	Incidents: 1. Thursday 11 th Sept – Speeding, noisy cars on The Rover Site. A resident saw and heard half a dozen cars on the East Works site on the very far area behind the old car park/The Grove. They were chasing each other around and making a fair bit of noise. A 999 Police call was made, the Police responded, but did not feedback. The next morning the resident passed the old security hut (by Focus) and rang the telephone numbers of both security firms whose signs say they patrol the property 24 hours. Both denied they had a contract! Two police cars pulled up and explained that the police are using the East works land for training purposes, Royal duties etc and this involves car chases! training exercises were taking place. 2. Burglary, Monday 22 Sept ,Barnt Green Road. This home was also burgled in August. Homeowner went upstairs and heard a noise down stairs. She went to investigate and found two young men (white, mid twenties) standing there. They had broken in through her patio doors at the back of the house. She actually said to them "can I help you?" and at that, they fled. They went out the way they got in, ran down the passage way between her house and the garage and scaled a 6' high gate leading onto Barnt Green Road. Burglary, Kendal End Road – Sunday night – 21st September. House broken into at the Barnt Green end of the road. The occupants were away, but the burglar alarm went off and neighbours called the police. The police responded very promptly. 4. Attempted break-in, Kendal End Road - Monday midday - 22nd September. Again at the Barnt Green end of the road. The burglars were foiled by good locks fitted to doors. Again the police responded very promptly. 5. Burglary, Cofton Church Lane - 3:00 am Sunday morning - 28th September. The occupants were woken up by hearing their front door opening. They went downstairs and found a youth in the hall who took a handbag and ran off. It appears that the front door had been forced. The Police were informed and attended the scene. 6. Oakfield Drive -this week: Large, heavy, old, Cast Iron grass roller taken from front garden - reported to police. Possibly taken by rag and bone men, but not witnessed? There is great concern about the burglaries (please see police feedback report), we can only encourage everyone to report any suspicious activity immediately. It will be interesting to see if the Smartwater / NW Road signs prove to be a deterrent. The subcommittee were asked to request a greater, visible, uniformed police presence around The Barnt Green Road / Cofton Carol Church Lane area. It was noted that Police cars had been witnessed around Ashmead Rise in the evenings. Police Report. Information supplied by Sgt Mark Wilkes and PC Jayne Willetts: As mentioned at the previous meeting - The man with the "Pot Belly" is currently in a West Midlands Custody Unit, and will probably be returning to prison. It has been a very busy time for burglary and attempt burglary. We wish to erect the signs as soon as possible, as this sends a clear message and deterrent to any criminal. The Wheelie Wizards have offered to assist which was accepted at the meeting. Smartwater Kits. The kits and registration procedure were presented at the meeting. Co-ordinators collected their orders for distribution. Registration must be completed to render each Smartwater Kit effective. Anyone who may have missed the order date will be able to make a direct order via our next edition of "Cofton Watch" (as agreed with Mel Clarke). 5.	Police Feedback. Presented by Sgt Mark Wilkes Sgt Wilkes presented further information regarding Operation Emblazon in Rubery, which was organised as a response to Rubery PACT. Police are concerned as vehicles, many of which have had modifications, were being driven around Rubery in timed circuits. They were being driven in a dangerous manner, in relation to speed, tailgating, handbrake turns, wheel spins, and overtaking. Three vehicles were seized for having no insurance. Two people were arrested and a number of fixed penalty tickets were issued. Sgt Wilkes added that some of the drivers involved were employed by local fast food restaurants to deliver food. Around ten vehicles were identified as not the appropriate insurance to cover them for business use. Their drivers are therefore liable to be prosecuted and the owners of the food outlets may also be prosecuted in relation to using delivery drivers with inadequate insurance. He added that this activity may disperse elsewhere. We raised concern for Lowhill Lane as a possible target. Any incidents must be reported immediately. Recent Burglaries in Cofton - One involved the burglar punching through a glass front door and activating an alarm and another occurred whilst a family were asleep in bed. Everyone is encouraged to review their home security measures and to avoid leaving keys on show. Members were asked to report any sightings of a man behaving suspiciously with the following description: White, 5'8", short black hair, aged 30 and with a distinctive pot belly. This is believed to be a prolific burglar. They are able to seize drugs, demand the name and address of those caught in possession of drugs and to also stop cyclists flouting the law (The Advertiser July 23 rd). "Horse Watch", a dedicated network of horse owners who share information, are using SMARTWATER for protecting their saddles, bridles and other equipment. Two applications for play areas to become "Alcohol Free Zones" have been denied in Bromsgrove. This decision was made due to insufficient evidence, as only three incidents have been reported for the two areas in the past two years. It is clear that the majority of the problems are actually on West Midlands as Cofton Park is the where most of the alcohol incidents are being reported as taking place, but the residents live in Worcestershire and so the impact is felt more there as they over look the park, and have the youths roaming around the streets whilst under the influence of alcohol, setting fire to the trees, and causing asbo.

Good morning – I am a resident of Cofton Hackett and live at Oakfield Drive. I have only just been informed of the proposal to make parts of Cofton Hackett an alcohol free zone and understand that Oakfield Drive might be included.

I have lived at Oakfield Drive for almost 10 years and have only been disturbed about half a dozen times by 'revellers' being noisy as they pass my house – most of these have been by people leaving a neighbours house after a party. I do not consider this a nuisance. We sleep at the front of the house with our bedroom window open so are likely to be disturbed by any loud noise.

I understand that the main problem of noise from drinkers is more felt on Groveley Lane, Ten Ashes Lane and perhaps Chestnut Drive and can fully understand the need to make that an alcohol free area. However, Oakfield Drive is well away from these roads and does not suffer from this nuisance.

Please do not include Oakfield Drive in this exclusion.

I am aware that several of my neighbours feel the same and I hope they make their feelings known to you.

I am responding to your invitation to comment on the proposal to make a Designated Public Place Order to restrict public drinking in the Groveley Lane area of Cofton Hackett.


I appreciate that this invitation provides me with an opportunity to offer adverse representations to be considered by Bromsgrove District Council's Licensing Committee in May 2009.
