HEARING PROCEDURE

- 1. The Chairman will open the hearing and introduce members of the Sub-Committee and officers present.
- 2. The Chairman will ask all other people present to introduce themselves.
- 3. The Chairman will remind the Applicant and each party present that they can be represented by a legal representative at their own expense.
- 4. The Licensing Officer will present the report.
- 5. The Chairman will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the Licensing Officer.
- 6. The Chairman will invite the Applicant and/or his/her representative to present his/her case and call any witnesses. The Applicant will be allowed a maximum of 10 minutes to present the case.
- 7. The Chairman will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the Applicant.
- 8. The Chairman will invite the Responsible Authorities to present their representations. New representations must not be raised. The Responsible Authorities will be allowed a total of 10 minutes to present their case(s). If two or more Responsible Authorities wish to address the Sub-Committee the 10 minutes will be divided between them.
- 9. The Chairman will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the Responsible Authorities.
- 10. Interested Parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised. A maximum of 10 minutes will be allowed for the Interested Parties to present their case(s). If two or more Interested Parties wish to address the Sub-Committee the 10 minutes will be divided between them.

- 11. The Chairman will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the Interested Parties.
- 12. The Interested Parties will be invited to sum up. A maximum of 5 minutes will be allowed.
- 13. The Responsible Authorities will be invited to sum up. A maximum of 5 minutes will be allowed.
- 14. The Applicant will be invited to sum up. A maximum of 5 minutes will be allowed.
- 15. At the conclusion of the hearing all parties, including the Licensing Officer, will be asked to withdraw. The Members of the Sub-Committee, the Legal Adviser and the Committee Services Officer will remain.
- 16. Once the Sub-Committee has reached its decision, all parties will be invited to return. The Sub-Committee's decision, together with the reasons for the decision, will be announced by the Chairman.
- 17. The Sub-Committee's decision will be confirmed in writing to the Applicant and those parties who made representations.

Please Note:

- 1. Each application coming before the Licensing Sub-Committee will be treated on its own merits, and the Sub-Committee will take its decision based upon:
 - a) the promotion of the four licensing objectives, as given by the Licensing Act 2003, namely:
 - the prevention of crime and disorder;
 - public safety;
 - the prevention of public nuisance; and
 - the protection of children from harm;

- b) Bromsgrove District Council's Statement of Licensing Policy;
- c) guidance issued under section 182 of the Licensing Act 2003; and
- d) the Licensing Act 2003.
- 2. The Chairman may require any person who in his/her opinion is behaving in a disruptive manner to leave the meeting, and may refuse to permit that person to return, or permit him/her to return only on such conditions as the Chairman may specify. However, such person may, before the end of the hearing, submit in writing any information which he/she would have been entitled to have given orally at the meeting had he/she not been required to leave.
- 3. Decisions may be taken in the absence of the Applicant or any other party. All notices and representations received from absent parties will be considered.
- 4. Questioning must not be hostile or intended to unfairly undermine the position of any party.
- 5. Late evidence will only be considered with the agreement of all parties present.
- 6. In cases where a decision cannot be given at the end of the hearing, the decision will be made within 5 working days.
- 7. An appeal to the Magistrates' Court against the Sub-Committee's decision must be lodged within 21 days of the date on which all parties were notified in writing of the decision of the Licensing Sub-Committee.

1. **SUMMARY**

1.1 To consider an application to review a Premises Licence in respect of the Duke of York, Broad Street, Bromsgrove.

2. **RECOMMENDATION**

2.1 That Members review the licence based upon the representations received.

3. BACKGROUND

- 3.1 The Licensing Authority has received an application from a local resident in accordance with the Licensing Act 2003 to review the above-mentioned licence. The grounds for the review are set out at Appendix 'A'.
- 3.2 Members may wish to note that a number of written warnings have been issued by the Licensing Authority on 24th February and 29th June 2009, informing the Licence Holder of the need for improvement in terms of keeping the volume of the music down to an acceptable level, ensuring that all windows are kept closed in accordance with licence conditions. A joint site visit with the Police has also taken place on 5th June 2009 and the Designated Premises Supervisor was informed of the concerns expressed by local residents.
- 3.3 The current hours of operation are as follows:

- 3.4 Details of licence conditions currently attached to the licence are set out at Appendix 'B'. Members will note that a number of conditions were placed on the licence by the Licensing Authority as a result of a previous application to vary the premises licence which was determined by the Council's Licensing Sub-Committee on 19th September 2005, as a consequence of representations being made by local residents.
- 3.5 As part of the review process, responsible authorities and interested parties are entitled to make representations. Responsible authorities include the Police Authority, Planning Authority, the Council's own Environmental Health Department, Fire Authority, Trading Standards and the Area Child Protection Committee.
- 3.6 On this occasion, a representation has been received from the Council's Environmental Health Section on the grounds of public nuisance. During the consultation period, the Council's Environmental Health Section carried out monitoring of the regulated entertainment and their findings are contained in the report is attached at Appendix 'C'. It is clear from the outcome of the monitoring exercise, that the premises was in breach of a number of its licence conditions.
- 3.7 A representation has also been submitted by West Mercia Police Authority, who has expressed concern over the management of the premises. A copy of their report is attached at Appendix 'D'.
- 3.8 A number of representations have also been received from local residents as a result of advertising the review application in accordance with the Act. Copies of their representations are attached at Appendix 'E'.
- 3.9 Leading up to and during the consultation period, the applicant, Mr. Smith has regularly informed the Licensing Authority of any incidents which were of concern to him. A copy of these incidents are attached at Appendix 'F', however certain references to personal information have been redacted to comply with data protection.
- 3.10 No representations have been received from the other responsible authorities.
- 3.11 A plan showing the location of the premises is attached at Appendix 'G'.
- 3.12 A plan showing the layout of the premises is attached at Appendix 'H'.

4. FINANCIAL IMPLICATIONS

4.1 There are no direct financial implications arising from this Report. However if either party made a successful appeal to the Magistrates' Court against the decision of the Council, the Council may be liable for any legal costs.

5. **LEGAL IMPLICATIONS**

- 5.1 Each party is entitled to appeal to the Magistrates' Court if they are dissatisfied with the decision of the Council, within 21 days from the date of decision.
- 5.2 The Sub-Committee must have regard to the Statutory Guidance, issued by the Secretary of State under Section 182 of the Licensing Act 2003, in particular the determination of a review. The following is an extract taken from the Statutory Guidance:

"The 2003 Act provides a range of powers for the licensing authority on determining a review that it may exercise where it considers them necessary for the promotion of the licensing objectives.

The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives.

Where the licensing authority considers that action under its statutory powers are necessary, it may take any of the following steps:

- to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition);
- to exclude a licensable activity from the scope of the licence;
- to suspend the licence for a period not exceeding three months;
- to revoke the licence.

In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than a necessary and proportionate response.

Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as a necessary means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review

- to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is necessary and proportionate to the promotion of the licensing objectives."
- 5.3 The Sub-Committee must have regard to the Council's Statement of Licensing Policy.
- 5.4 The conduct of the Sub-Committee is governed by the Licensing Act 2003 (Hearings) Regulations 2005, as amended.
- 5.5 The Sub-Committee is reminded that the Human Rights Act 1998 guarantees the right to a fair hearing for all parties in the determination of their civil rights.

I have in the last three months or so since this team took over the "DukeOf York" spoken to the manager about the noise swearing and anti social behavior from these premeses I asked him (mr Mark Rowen) Johns brother to ask John if he would speak to me about the problems i had had the reply i got was "he will not speak to you he will not stop it he he will not change it" All the details have been logged via emails to "Ms Sharon Smith" via emails as i suffer with dyxlexia and find it hard to keep written recordswith out the aid of spell check

Basicly the noise from discos/kareoke to customers smashing glasses out side swearing urinating in the flower beds and up walls and out and up the wall opposite my house shouting obscenities at passing cars the swearing was also being done by the now manager

I have spoken to the area manager who prommised to get back to me after i called twice with my problems (He did not); the noise and anti social behavior got worse they have took no notice of the previous review held when mr K miller was there ie windows and blinds open whilst music is being played and people @swearing and shouting out side until the early hours

I can not get them out of comuter to paste to this copy (i am sure that it is possible but i can not do it) but i have enclosed a summary on a separate sheet which Ms Smith has the details both people that i saw urinating in public are still allowed in the premisies

All these details of the worse times as i said are logged with Ms Smith (would you ask her for details (as i have trouble printing them of) but i have sent a summary **

I would like to see no drinks out side after 18.00hrs and any shouting swearing or anti social behavour the management sort it out there and then this is a residential area i would also like to see that when music is being played the blinds windows and doors all to be shut and the noise kept down to legal levels the benches put behind the screened area or at least down the side where they were put after the council and police visited on 5/06/09 one of them was put back out the front at approximatly 16.00hrs on Sunday 7/06/09 this will eliviate the problems of the management not seeing what is going on and stop the shouting at passing cars and drivers passing sounding the horn whilst they pass and the cheering and shouting back of obscenities also signs put up to say keep anti social behavior and swearing will result in a ban from the premises or word to that efect and sticking to it also i would like to see the whole area tidied up and the loose bricks moved away or re fitted so that they can not be used as misiles which i am sure will happen as the whole area is an eye sore the waste bins emptied more often not being left over flowing

The lack of sleep these premisies has cause me has got me in to trouble at work for the first time since i worked ther (over four years)

Whilst i know that if i buy a house by a pub i can expect some problems but not swearing and shouting all night most nights and all week end music being played that loud that i can hear it inside my house with the windows shut and i can no longer use the front of my house i also could not let my mother or grand children stop and why should i have to shut the windows in the summer anyway

All of the problems i have had with the pub in the past i have managed to sort out with a quet word with the previous managers this has been only twice once damage was done to my fence which was sorted amicably and once noise fron people who's taxi did not turn up after closing in early hours after a disco and extension and Paul used to ask people to leave quietly and think of the neighbers

Noise and disturbance in April and May June that I have heard 30/05/09 some one urinating up the side of the pub @21.00hrs swearing 21.30 @23.00 26/05/09swearing @20.00hrs

24/05/09 noise all night both inside and out windows open 20.30 hrs till 23.59hrs

23/05/09 swearing and shouting 23.48hrs 00.06hrs 0107 hrs out side pub (02.00hrs along side my house I do not know if they came from the pub) affecting my health and work

05/05/09 I am told there was the police and ambulance at the pub. Then at 00.15 hrs a young man walking up the road from the pub with two full glasses he dropped one the manager gave this mans mate who was also in the pub a dust pan and brush to clean it up this person urinated up the wall opposite my house

I spoke to area manager who promised to calm it all down and get back to me (he

did not)

27/04/09 windows open all night noise from inside and out

11/04/09 disturbance and shouting at mid night

06/04/09 noise all evening till around midnight on car park

30/03/09 the assistant manager who is now the manager shouting a tirade of swear words to people who were sat on the benches at 21.30 hrs

I have only started a log after weeks of nuisance and noise I will not be convinced that

Having the new man at the pub will be any different as he has worked at the pub from the day this group took over the only difference is a different man behind the bar as this man has been on site on many of the occasions i.e. attending or working behind the bar at the Karaoke and disco's and he has been part of the problem with his own language

Not only is this affecting my health and my work it is affecting the value of my

house

I did ask the licensee to speak to me also I have told the area manager that he would not speak to me who also did not bother to get back to me with any answers

04/06/09 with the new manager to day when he drove from the car park at about lunch time one of the people shouted after him "suck this you f**king prick also there were other incidents of foul language from off the benches and also the windows were open at 17.00 hrs I shut the windows at the front of my house as they were playing drum and bass music whilst I was eating my evening meal I could hear it over the radio in my dining room I did see "Barney Kelso" on his mountain bike I do not know if he heard any of the language as went off up Broad Street

I would like to see the benches moved from the front of the pub and a drinks ban outside discos and karaoke the windows and door kept shut whilst music is being played or whilst discos and karaoke nights are going on I do not think that a change of management has made any difference as today proves the point not once whilst the swearing was going on did I hear or see any one say to these people to pipe down

Annex 1 - Mandatory conditions

1 Annex 1

Mandatory Conditions

- (a) No supply of alcohol may be made under this Premises Licence at a time when:
 - There is no designated premises supervisor in respect of the Premises Licence; or
- At a time when the designated premises supervisor does not hold a Personal Licence or his/her Personal Licence has been suspended.
- (b) Every Supply of alcohol under this Premises Licence must be made or authorised by a person who holds a Personal Licence.
- (c) If any person is employed to be responsible for security, protection, screening the suitability of people entering the premises or dealing with conflict in pubs, clubs and other licensed premises open to the public shall be registered with the Security Industry Authority (SIA).
- (d) Where a premises licence authorises the exhibition of films, the admission of children to the exhibition of any film is to be restricted in accordance with Section 20 of the Licensing Act 2003.

Other Conditions - Non-Standard Timings

- (a) With reference to Non-Standard Timings, all licensable activities will be permitted between 11.00 a.m. and 12.30 a.m. for the following notable days/dates:

- (b) With reference to Non-Standard Timings, all licensable activities will be permitted between 12 noon and 12 midnight for the following notable days/dates:
- Every Sundary for every bank holiday, namely Easter, early May Bank Holiday, Spring Bank Holiday and August Bank Holiday.
- (c) With reference to Non-Standard Timings, all licensable activities will be permitted between 12 noon and 3.00 p.m. and 7.00 p.m. and 10.30 p.m. for the following notable days/dates:
- · Christmas Day.

With reference to the application for review of the above mentioned Licence, I have been asked to comment on the application.

My remit is to look the third Licensing objective "prevention of public nuisance".

In this respect the annoyance caused by the loud playing of music is within my remit, matters relating to anti social behaviour are outside my jurisdiction.

One of my team members has been tasked with carrying out an evening visit to assess the extent of the noise problem, they will report separately regarding this.

I have carried out a daytime inspection of the exterior of the premises; it consists of a public bar and a separate lounge/ function room. The premises are in a predominately residential area with the closest dwelling to the function room being 11 metres away. The building is of typical 1960s style being constructed with a flat roof surmounted by a separate flat over to provide accommodation for the Licence holder.

The lounge/function room is served by two large windows with five openable top hung windows, and an extractor fan outlet. The Public Bar is similarly served with two large windows with five openable top hung windows and an extractor fan outlet.

It has been reported that music being played in the function room has been causing annoyance to nearby residents, the current Licence condition in Annex 2 (9) states:-

"All windows and doors will be kept closed after 23.00hours"

With the current licensable activities this condition will not prevent annoyance to residents.

I would recommend that this condition be removed and replaced with

"All windows and doors to be kept shut when licensable activities (B. to I. inclusive) are taking place, doors to be opened only for access and egress.

In addition to this, noise may also emerge through the extract ducting in the walls; the evening site visit may reveal the extent of this problem. If it is found to be allowing noise to emerge, then work to acoustically treat the ducting outlet will have to be undertaken. Alternatively, air conditioning could be installed to serve the function room and the extractor fan outlet could be bricked up.

I trust this information is sufficient for your purposes.

I Michelle Heather Lowe am employed by Bromsgrove District Council as a Pollution Control Officer in the Environmental Health Section and am authorised to carry out duties under the provisions of the Environmental Protection Act 1990.

I was asked on the 16th June 2009 by my Team Leader, Robin Goundry, to visit the area around The Duke of York, Broad Street, Bromsgrove between 2200 hours and 0000 hours at a weekend to assess the extent of any noise problems following an application by a nearby resident for the review of the premises licence under the Licensing Act 2003.

On the 27th June 2009 at 2210 hours I parked my car, with my windows open, outside 88 Broad Street, Bromsgrove which is opposite the Duke of York. Music including words and melody could be clearly heard. A window of the Duke of York was open on the Broad Street side. I could also hear people singing along and could clearly hear everything the DJ was saying. With the windows of the car closed I could still hear the music but more muffled. I could make out most of the words to songs and could easily distinguish what song was being played. At 2218 hours they were doing karaoke. At 2223

hours I moved to outside 5 York Road, Bromsgrove. There were a number of windows open on the York Road side of the premises in question. With the windows of my car open I could hear lyrics and melody to the song above the sound of passing traffic. With the windows closed I could make out a few words and all the melody. There were a few people (about 10 to 15) outside the Duke of York sat on benches. There was some shouting. I left the area at 2227 hours.

At 2310 hours on the 27th June 2009 I arrived outside 5 York Road listening to music from The Duke of York, Broad Street, Bromsgrove. Two windows were open at the premises and music, with the windows of the car open could be clearly heard. I could hear the beat and the melody but the lyrics were muffled. I could pick out what song was being played. It sounded like Karaoke. There where a number of people outside talking and shouting. With the windows of the car closed I could still make out individual lyrics and some of what the DJ was saying. It was a warm, dry evening. At 2319 hours I moved outside 88 Broad Street. One window was open at the premises. In the car with the window open I could clearly hear the melody and lyrics of the song. 'My life would suck without you' by Kelly Clarkson was being played. It was very loud. I left the area at 2322 hours.

At 2355 hours I arrived outside 88 Broad Street, Bromsgrove. The windows of The Duke of York were closed. I could not hear any music. The lights of the disco where still flashing and there where people outside shouting. At 2358 hours I could just make out the melody of the music with the windows of my car open but I could not make out what the song was or the lyrics. I moved to York Road. No windows where open and no music could be heard.

At 0006 hours on the 28th June 2009 I could hear music with the windows of my car open, parked outside 88 Broad Street. I could just hear the melody and not individual lyrics. I could not recognise what song was being played and could not hear it above passing traffic. At 0009 hours the lights from the disco went off. I left the area at 0015 hours and no music could be heard.

From what I had witnessed I conclude that with the windows open during regulated entertainment annoyance to residents from loud music is being caused. It is my opinion that the condition "All windows and doors to be kept shut when licensable activities (B. to I. Inclusive) are taking place, doors to be opened only for access and egress" recommended by Robin Goundry would significantly reduce the level of disturbance witnessed.

The Police are aware that the basis of the review has been brought about due to noise nuisance and anti-social behaviour in and around the premise. This review has been commenced by a local resident(s).

Following notification of review proceedings, West Mercia Police would like to make the following comments around the running of this public house.

I have checked West Mercia Police incident logs (ois system) with regards to incidents linked to this public house.

Since the beginning of 2009 there have been only a handful of incidents reported. A small number of these are anti-social incidents around noise nuisance, but I have to say these have been minimal. Reports around crime and disorder, which have been reported to Police, are again, minimal.

The only concerns West Mercia Police have with the Duke of York and its compliance with the Licensing Act 2003, are around the role of the listed designated premise supervisor (DPS).

On 5th June 2009, Police Licensing Officer Neil Sharpe and Bromsgrove Council Licensing Officer John Davies visited the premise to discuss noise nuisance. They were met by Mr Gary Darby. Mr Darby explained that he was the new manager of the pub. He said that he wasn't a personal licence holder, but he was arranging to go on a course as soon as possible. Mr John Rowan is the DPS. He is also the DPS for the Dog and Pheasant Public Property of the property of

The Police would question whether Mr Rowan has any supervisory role at the Duke of York. He is based at the pub in Redditch and he has recently lost his driving licence, so his ability to travel between premises is therefore restricted. So as of today's date, no personal licence holder is present when alcohol is sold at the Duke of York.

Mr Darby has informed both the Police and Bromsgrove council that he has taken the BII personal licence holders course and is awaiting his criminal records checks to be returned before he can apply for a personal licence. He says he will then be applying to be the pubs DPS.

The Police will be monitoring the supervisory role closely. If, by the time of this review, Mr Darby is still waiting for his personal licence we would have no alternative but to look at options to rectify the situation.

I write in support of Richard Smith, who has, I believe, contacted you re the above.

I have lived on Broad Street, diagonally opposite the pub for 16 years.

Disturbance from the pub has not been great until recently. The previous landlord held disco nights with very loud music occasionally (usually bank holidays).

This has now increased to at least once a week.

The music is loud with persistent bass-beat (which makes it difficult to even watch TV) and the most annoying element of this is that there's total disregard for any of the neighbours – all the windows and doors are kept wide open and there's obviously no sound-proofing. When the pub empties there is then loud, aggressive behaviour and the usual foul language which goes on into the early hours.

Also with the car park front being by the exit / entrance from York rd it is dangerous and this is another reason for having smokers down the side where there is plenty of room also the noise would be less as customers would not be shouting to others through the windows and door as happens now.

Is it a new manager or a complete new team as is the brother of the licensee is the manager? If the side is unsafe then something needs doing to protect people who use that side of the car park including children as it is not cordoned off if you meant behind the fence the gate is open most of the time anyway

I feel that the side of the building would be a better idea for smoking not out the back as suggested by your officer

When you say the back is unsafe do you mean behind the fence? as i meant this side of the fence but to the left hand side of the pub looking from the front still on the car park would be the best place for a shelter or the benches

I do not want to be a killjoy and understand that if you buy a house by a public house then a certain amount of noise is inevitable but there has been so much noise and disturbance since this team moved in. I feel that the windows could be left open until sunset or 22.00 hrs as with the benches but after that time our peace should be taken in to consideration this is a residential area after all



Afternoon Sharon on Friday last 27/03/09 one of the employees from the "Duke Of York" went from the car park with a woman in his silver Rover car S289 MAB 21.30 hrs approx his language was colourfully to say the least. This on its own proves to me that they have taken very little notice of your previous warnings. Also at about the same time some one from the pub in a group of about 12 who were out side drinking and smoking was throwing something towards the electricity sub station opposite i am unsure what he was throwing but i saw this twice and their was a slight whistle to it like a fire work sounds THIS WAS NOT A FIRE WORK as there was no smoke and the noise was hardly audible the noise from the Karaoke would have been acceptable if the windows and doors were kept shut i think the answer to be stop people coming out side with there drinks i know they have to smoke out doors and keep the windows shut this would then mean that large groups of this size would not be hanging around being rowdy they would smoke there cigarette and go back in

I have never had so much trouble with rowdiness and noise in the ten years that i have lived here on the two other occasions i have been able to sort it out with the managers i have invited this man to talk to me but the manager says he will not meet me


