The above premise is applying for an alcohol licence from 10am until 11.30pm.

I welcome the idea of a micro pub in Barnt Green.

However, I have been contacted by Residents and I share their concern that as the premises is situated a in semi residential area with approximated 15 homes within 50m and at least 6 considerably closer, late night noise nuisance will be an issue. I am also unsure as to if the application encompasses outside space?

Within the locality I can think of two other micro pubs, Alestones in Tardebigge which closes at 9pm and The Little Ale House in Bromsgrove which closes at 8pm.

Recently, a restaurant licence application was granted for Cork and Crust on the opposite side of Hewell Road and they close at 10pm.

I would therefore like to suggest that this application be modified to allow alcohol to be served and consumed from 10am until 10pm inside the premises and until 9pm outside the premises.

Please could you advise me whether this application is to be put before a licencing subcommittee or if delegated powers will be used to decide the outcome.

I am writing to express my concern about this application for various reasons.

I consider this location to be inappropriate to be converted to another drinking establishment. It is situated adjacent to, and opposite, residential dwellings inhabited by elderly people and young children, for whom the proposed late licensing hours of 23.30 could cause public nuisance.

Furthermore, where are the visitors to this establishment going to park their cars? The centre of Barnt Green already has a dire parking problem, much exacerbated by the recent opening of the Cork and Crust - another of several examples of traditional retail/commercial premises being converted into eating and drinking establishments. The village has a large pedestrian population elderly people walking to the shops and local amenities, children walking to and from St Andrew's School, toddlers from two day-nurseries being walked around the village - and the risk to life and limb by excessive road traffic and inconsiderate parking is already increasing to an alarming level. Local residents, and people visiting them, have nowhere to park or to stop in order to unload. This proposed establishment will only add to the problem.

So, to summarise, my objection is on the grounds of :

Public nuisance from late-night noise and alcohol-related behaviour

Accessibility

Risk to public safety from increased traffic in a village where there is already a serious and everworsening traffic problem.
