

The local shop and Post Office, forming part of this freehold premises provides a vital service for the residents of Fairfield. The café is a local point of community contact. The premises thus enhances the social wellbeing of residents particularly those who do not have access to their own transport to enable usage of similar services a distance from their homes. The elderly especially would suffer should these services cease to exist. Indeed, having such services locally means that less traffic is generated elsewhere in the adjacent parish areas as those with transport will have no alternative but to use their cars. The public transport services are felt to be barely adequate and always appear to be subject to review as regards sustainability. Having a local shop and Post Office helps maintain social cohesion. Current use as a Post Office and general stores plus café should continue and uses may be enhanced with local initiatives to promote greater use and variety of enterprises for the retail area of the site.
