I wish to inform you of my concerns regarding the application for a street trading licence on the "Layby" in Quantry Lane.

The position requested is not an official Layby but land that has been enlarged over the years and tarmaced to facilitate the delivery of stone/grit to the county council storage yard which is used periodically over the year and necessitates the placing of traffic light due to safety reasons. The area is only big enough for one of these vehicles at a time and would therefore not safely accommodate a traders vehicle, trailer and customers.

It is on a blind bend and would cause a road safety issue for users and potential customers. There is a traffic speed changes from 40 to 50 mph at the end of the area.

There are two food trailers sited on the nearby A491 dual carriageway in suitable lay-bys, both less than 3 mins, 1.5 miles away. There are also several nearby cafes providing similar food.

This area of the road in my opinion is not a safe area for the provision of a food trailer due to the speed, lack of view and limited space.



I am emailing to object to the Proposed Street Trading to take place on the layby in Quantry Lane, Belbroughton. DY9 9UU

The layby where the proposed trading will be is a small area, not much bigger than a pull in which is situated in a dip which is not visible to vehicles driving over the brow of the hill. It is a blind spot for vehicles.

The area is not big enough for cars/lorries to pull onto or to exit safely.

I live just above the brow of the hill and even though the road has a 40mph speed limit, drivers go by very fast. It is difficult at times to get in and out of my drive safely.

At 8 am when trading would commence the road is extremely busy with fast moving traffic.

I have noted several snack/burger vans locally and they are all situated within a large area, suitable for many lorries and cars to pull in and out safely. In areas which caters for both people wanting food and others who just want to stop for a break.

I am concerned that the layby would become congested and would increase the likelihood of accidents. Based upon this I feel the need to object to the proposal.
