Without adequate restroom options, patrons may resort to public urination or defecation, compromising hygiene standards and potentially spreading diseases.

Food waste and litter: Running a hot food van where operators dispose of waste improperly and customers litter can lead to a concerning proliferation of vermin and significant health hazards for both local residents and the rural environment. Neglected waste attracts rodents and pests, creating an unsightly and unsanitary landscape that can contribute to the spread of diseases. Moreover, the presence of vermin in a rural area can disrupt the local ecosystem and harm indigenous wildlife.
